1. Progress Update

Paul Carter discussed project status for the period ending November 2021 and recent events including a new amending agreement with GE, critical punch list deferrals, new milestone dates, and schedule risks, deferral of planned December 2021 high power testing, synchronous condensers status, Astaldi arbitration status, and Committee reporting, minutes and Q3 quarterly report.

2. NL Hydro Project Updates

Project Update

Project update including discussion on safety performance, key monthly highlights including synchronous condensers update - planning for mid - January 2022 100% load test, mobilization of contractor to Soldiers Pond to commence bearing replacement of bearing damaged in November 2021 and to be completed by June 2022, LITL operations update - with software released to site in December 2021, the LITL was release for operations up to 450 MW, LITL has operated up to 415 MW without incident, LITL will be offline when synchronous condenser load test is performed, coordination is ongoing with Hydro and interconnected partners to schedule high power testing which was deferred from December 2021, use of LITL will be optimized with the current version of software until new software is received, full function bipole status update - negotiations, new amending agreement with GE, punch list breakdown and deferral of agreed critical punch lists with a six month burn in period to resolve bugs, new milestone dates and schedule risks, cost risks within and above the September 2021 project budget, LITL completions certificates status, MFGen status update – units 1 and 2 in operation, unit 2 output steady at 140MW update, resolution of unit 2 vibration issue is pending a solution from Andritz, units 3 and 4 in operation, Astaldi arbitration decision from panel is still pending, and project team ramp down projections.

3. Committee Business

The Committee discussed NL Hydro's project updates including software completion risk and reliability of the new milestone schedule, synchronous condensers vibration remediation, and Committee future reporting requirements.
