#### ASSESSMENT OF WORKPLACE SKILLS

The assessment of workplace skills will be completed using challenge methods. This means the trade qualifier will have to participate in practical and/or theoretical assessments of their abilities and knowledge. The methods used to determine competency in each workplace skill must, as closely as possible, assess the skill at the level it would be performed by a journeyperson in the workplace.

The following directions should be observed when selecting assessment tools;

- Assessment tools may be existing items used to test students in full time training, or they may be created specifically for TQ assessment.
- Where a workplace skill requires demonstration of both theoretical and practical knowledge and ability, assessment must take place on both.
- All theoretical and practical knowledge and ability must be demonstrated in a school environment, under the supervision and observation of the designated assessor.
