Special Measures Order (Alert Level 4) (St. George's, Stephenville, Port-au-Port area)

Made pursuant to Section 28 of the Public Health Protection and Promotion Act

May 30, 2021

TO: All individuals and businesses in the towns and communities located along the following highway routes in the province of Newfoundland and Labrador:

- Route 460;
- Route 461;
- Route 462;
- Route 463; and
- Route 490.

WHEREAS:

- A. While a declaration of a public health emergency is in effect, the Chief Medical Officer of Health may do one or more of the special measures authorized under section 28 of the **Public Health Protection and Promotion Act** for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency;
- B. On March 18, 2020, the Minister of Health and Community Services, on the advice of the Chief Medical Officer of Health, declared:
 - (i) a public health emergency as a result of the COVID-19 pandemic;
 - (ii) the public health emergency is in effect for the entire province of Newfoundland and Labrador; and
 - (iii) the public health emergency is in effect for a period of 14 days effective immediately;
- C. The public health emergency has been extended for 14-day intervals and is currently still in effect;
- D. The Chief Medical Officer of Health, pursuant to subsection 28(2) of the Public Health Protection and Promotion Act, may provide notice in any manner that can reasonably be expected to give actual notice;

- E. The Chief Medical Officer of Health, pursuant to section 28 of the **Public Health Protection and Promotion Act**, made Special Measures Order (Updated Alert Level 2) effective April 17, 2021;
- F. The Acting Chief Medical Officer of Health believes that further special measures are necessary for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency; and
- G. The Acting Chief Medical Officer of Health believes, in accordance with section 13 of the **Public Health Protection and Promotion Act**, that the restrictions set out in this Special Measures Order (Alert Level 4) (St. George's, Stephenville, Port-au-Port area) are the least intrusive measures reasonably required in the circumstances to respond to the public health emergency,

Pursuant to section 28 of the Public Health Protection and Promotion Act, I, Dr. Roseann Seviour, Acting Chief Medical Officer of Health HEREBY ORDER:

Notwithstanding Special Measures Order (Updated Alert Level 2),

- 1. The following businesses are ordered to close:
 - (i) gyms and fitness facilities, including yoga studios, swimming pools, tennis and squash facilities;
 - (ii) dance studios;
 - (iii) cinemas;
 - (iv) performance spaces;
 - (v) arenas; and
 - (vi) businesses that hold a license under the **Liquor Control Act** whose primary purpose is the consumption of beer, wine, or spirits.
- 2. Restaurants are ordered to close for in-person dining. Take-out, delivery and drive-thru services are permitted.
- 3. Bingo halls are ordered to close.
- 4. Wakes and visitation are prohibited. Funerals, burials, weddings, religious and cultural ceremonies are limited to no more than 10 people provided physical distancing may be maintained. With the exception of immediate family members as necessary for child care purposes or to provide support to isolated people, all other gatherings are limited to those individuals within the same household. For greater certainty, this limitation on informal gatherings does not apply to:

- a. those who work or attend school outside of the home; and
- b. custody and access orders and arrangements.
- 5. All private health care clinics may remain open in accordance with public health quidelines.
- 6. Retail stores, including those located in shopping malls, may remain open at 50 per cent capacity.
- 7. Personal services establishments including spas, esthetic services, hair salons, body piercing, tattooing and tanning salons may remain open in accordance with public health guidelines.
- 8. All individuals who are required to self-isolate or quarantine must:
 - a. remain on their own property;
 - stay in their own unit where they are living in a condominium or apartment.
 These individuals are not permitted in the common spaces in those buildings; and
 - c. not go for a drive, unless it is to receive medical attention.

IT IS FURTHER ORDERED THAT:

- 1. This Order applies all individuals and businesses in the towns and communities located along the following highway routes in the province of Newfoundland and Labrador:
 - Route 460:
 - Route 461;
 - Route 462;
 - Route 463; and
 - Route 490.
- 2. This Special Measures Order (Alert Level 4) (St. George's, Stephenville, Port-au-Port area) is effective as of 4:00 p.m. on May 30, 2021.
- 3. All other Special Measures Orders remain in full force and effect.

TAKE NOTICE THAT:

 Failure to comply with this order may result in an application to the Supreme Court, in accordance with section 42 of the Public Health Protection and Promotion Act to enforce the relevant provisions of this Order.

- 2. A person who is subject to an order made by the Chief Medical Officer of Health may request that the Chief Medical Officer of Health reconsider the order by filing a written request for reconsideration within 7 days after the day on which the order is served on a person. A written request for review or reconsideration of this order shall include:
 - (i) the reasons for the request;
 - (ii) a summary of the facts relevant to the request;
 - (iii) whether the order should be revoked or how it should be varied; and
 - (iv) the contact information of the person making the request and shall be sent to the following address:

- 3. The Chief Medical Officer of Health shall review this Order no less than once every 5 days while the Order is in effect.
- 4. This Order remains in effect during any review or reconsideration.
- Failure to comply with this Order is an offence for which you may be liable on summary conviction in accordance with section 56 of the Public Health Protection and Promotion Act.
- 6. For greater certainty, compliance with this Order is required in addition to and not in substitution for any requirement imposed by or under any applicable law.
