Special Measures Order (Activities and Gatherings Restrictions)

Made pursuant to Section 28 of the Public Health Protection and Promotion Act

February 10, 2022

TO: All individuals and businesses operating in Newfoundland and Labrador

WHEREAS:

- A. While a declaration of a public health emergency is in effect, the Chief Medical Officer of Health may do one or more of the special measures authorized under section 28 of the **Public Health Protection and Promotion Act** for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency;
- **B.** On March 18, 2020, the Minister of Health and Community Services, on the advice of the Chief Medical Officer of Health, declared:
 - (i) a public health emergency as a result of the COVID-19 pandemic;
 - (ii) the public health emergency is in effect for the entire province of Newfoundland and Labrador; and
 - (iii) the public health emergency is in effect for a period of 14 days effective immediately;
- C. The public health emergency has been extended for 14-day intervals and is currently still in effect.
- D. The Chief Medical Officer of Health, pursuant to subsection 28(2) of the Public Health Protection and Promotion Act, may provide notice in any manner that can reasonably be expected to give actual notice;
- E. The Chief Medical Officer of Health, pursuant to section 28 of the **Public Health Protection and Promotion Act**, made Special Measures Order (Modified Alert Level 3) effective February 7, 2022 and Special Measures Order (Modified Alert Level 3) (Gatherings Clarification) effective February 7, 2022;
- F. The Chief Medical Officer of Health believes that special measures continue to be necessary for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency; and

G. The Chief Medical Officer of Health believes, in accordance with section 13 of the Public Health Protection and Promotion Act, that the restrictions set out in this Special Measures Order (Activities and Gatherings Restrictions) are the least intrusive measures reasonably required in the circumstances to respond to the public health emergency,

Pursuant to section 28 of the Public Health Protection and Promotion Act, I, Dr. Janice Fitzgerald, Chief Medical Officer of Health HEREBY ORDER:

Sports, arts, fitness and recreational activities

- 1. Subject to Order No. 2 below, arenas, gyms and fitness facilities, including yoga studios, indoor swimming pools, indoor tennis, squash facilities and dance studios may operate at 50 per cent of the venue's capacity, per rink surface, playing space or room, provided that physical distancing may be maintained.
- 2. Amateur individual and team sport and recreation activities may return to competition that fall within the regular competitive schedule of an organization, team or group. Where regional competition is a part of the regular competitive schedule, participants are limited to competition against one single team per day. Tournaments are not permitted.
- 3. Group arts and cultural activities that involve in-person gatherings are limited to practices, rehearsals and performances within their own practice or performance group, with physical distancing maintained where possible between participants. This includes bands, choirs and music classes.

Religious, spiritual and cultural ceremonies

- **4.** Religious and cultural ceremonies and services, including funerals, burials and weddings are limited to:
 - a. no more than 50 per cent of the venue's capacity provided physical distancing may be maintained, where the proof of vaccination for persons entering their premises or participating in their services is verified in accordance with Special Measures Order (Proof of Vaccination Status Updated October 21, 2021), as amended; or
 - b. no more than 25 per cent of the venue's capacity provided physical distancing may be maintained, where the proof of vaccination for persons entering their premises or participating in their services is not verified in accordance with Special Measures Order (Proof of Vaccination Status Updated October 21, 2021), as amended.
- 5. Wakes are prohibited. Limited visitation is permitted with members of one household bubble visiting at a time.

Bars and Lounges

- 6. Businesses that hold a license under the Liquor Control Act, whose primary purpose is the consumption of beer, wine, or spirits may operate at 50 per cent of the Fire Commissioner's posted capacity provided physical distancing of 2 metres between patrons at adjacent tables may be maintained. There is a maximum of 10 people per table.
- 7. Dance floors are not permitted.
- 8. Patrons are permitted to eat and drink while seated only.
- 9. It is the responsibility of licensees to ensure compliance with this Order within their licensed footprint.

Restaurants

- 10. Restaurants may operate for in-person dining at no more than 50 per cent of the venue's capacity provided physical distancing of 2 metres between patrons seated at adjacent tables may be maintained. There is a maximum of 10 people per table.
- 11. Patrons are permitted to eat and drink while seated only.
- 12. Self-serve buffets are prohibited in restaurants and in businesses that serve food.

Other Gatherings

- 13. Subject to Order No. 4, funerals, burials, weddings and all other indoor gatherings, not otherwise listed, and operated by a recognized business or organization, occupancy is limited to no more than 50 per cent of the venue's capacity provided physical distancing may be maintained.
- 14. Cinemas are limited to no more than 50 per cent capacity per auditorium or room, provided that physical distancing may be maintained. Patrons are permitted to eat or drink while seated only and where physical distancing is maintained between patrons who are not close, consistent contacts.
- 15. Performance spaces are limited to no more than 50 per cent capacity per auditorium or room, provided that physical distancing may be maintained. Patrons are permitted to eat or drink while seated only and where physical distancing is maintained between patrons who are not close, consistent contacts.
- 16. Bingo halls are limited to no more than 50 per cent capacity per room, provided that physical distancing of 2 metres of distance between attendees seated at

- adjacent tables may be maintained. Attendees are permitted to eat or drink while seated only and where physical distancing is maintained between attendees who are not close, consistent contacts.
- 17. Notwithstanding any Order set out in this Special Measures Order, gatherings in large venues including theatres, performing arts venues, community centres, other entertainment venues and sports venues with a capacity of 500 or more may operate at higher than 50 per cent of the venue's capacity where an operating plan has been approved by an Environmental Health Officer with Digital Government and Service NL.
- **18.** For all other gatherings, individuals within the same household are limited to gatherings with the same 20 close and consistent contacts of the household. For greater certainty, this limitation on informal gatherings does not apply to:
 - a. those who work or attend school outside of the home; and
 - b. custody and access orders and arrangements.
- 19. Except for ceremonial dances, dancing at formal gatherings is prohibited.

Other Public Spaces

- **20.** All private health care clinics may remain open in accordance with public health guidelines.
- 21. Retail stores, including those located in shopping malls may operate at reduced capacity, provided physical distancing may be maintained.
- 22. Personal services establishments including spas, esthetic services, hair salons, body piercing, tattooing and tanning salons may remain open in accordance with public health guidelines.

<u>General</u>

23. Visitation to assisted living facilities, personal care homes and long-term care facilities is subject to those restrictions as may be communicated by the Office of the Chief Medical Officer from time to time.

- 24. Campsites are permitted to open for day use and overnight use subject to the Guidelines for Campgrounds General Restrictions as described in detail at www.gov.nl.ca/covid-19.
- **25.** All individuals who are required to self-isolate must:
 - a. remain on their own property;
 - b. stay in their own unit where they are living in a condominium or apartment. These individuals are not permitted in the common spaces in those buildings; and
 - c. not go for a drive, unless it is to receive medical attention.

IT IS FURTHER ORDERED THAT:

- 1. This Order applies to all individuals and businesses operating in Newfoundland and Labrador.
- 2. Except for Order No. 4 of this Special Measures Order (Activities and Gatherings Restrictions), which is effective as of 12:01 a.m. NST on February 12, 2022, all Orders in this Special Measures Order (Activities and Gatherings Restrictions) are effective as of 12:01 a.m. NST on February 14, 2022.
- 3. Effective 12:01 a.m. February 12, 2022, Order No. 4 of this Special Measures Order (Activities and Gatherings Restrictions) repeals and replaces Order No. 4 of Special Measures Order (Modified Alert Level 3).
- 4. Effective on February 14, 2022 at 12:01 NST, this Special Measures Order (Activities and Gatherings Restrictions) repeals and replaces all remaining Orders, in Special Measures Order (Modified Alert Level 3) effective February 7, 2022 and dated February 7, 2022 and Special Measures Order (Modified Alert Level 3) (Gatherings Clarification) effective February 7, 2022.
- 5. All other Special Measures Orders remain in full force and effect.

TAKE NOTICE THAT:

- 1. Failure to comply with this order may result in an application to the Supreme Court, in accordance with section 42 of the **Public Health Protection and Promotion Act** to enforce the relevant provisions of this Order.
- 2. A person who is subject to an order made by the Chief Medical Officer of Health may request that the Chief Medical Officer of Health reconsider the order by filing a written request for reconsideration within 7 days after the day on which the order is served on a person. A written request for review or reconsideration of this order shall include:

- (i) the reasons for the request;
- (ii) a summary of the facts relevant to the request;
- (iii) whether the order should be revoked or how it should be varied; and
- (iv) the contact information of the person making the request and shall be sent to the following address:

- 3. The Chief Medical Officer of Health shall review this Order no less than once every 5 days while the Order is in effect.
- 4. This Order remains in effect during any review or reconsideration.
- 5. Failure to comply with this Order is an offence for which you may be liable on summary conviction in accordance with section 56 of the **Public Health**Protection and Promotion Act.
- 6. For greater certainty, compliance with this Order is required in addition to and not in substitution for any requirement imposed by or under any applicable law.
