Special Measures Order (General – Alert Level 2) (Gatherings Amendment) Made pursuant to Section 28 of the Public Health Protection and Promotion Act

August 24, 2020

TO: All Individuals and businesses operating in Newfoundland and Labrador

WHEREAS:

- A. While a declaration of a public health emergency is in effect, the Chief Medical Officer of Health may do one or more of the special measures authorized under section 28 of the **Public Health Protection and Promotion Act** for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency;
- **B.** On March 18, 2020, the Minister of Health and Community Services, on the advice of the Chief Medical Officer of Health, declared:
 - (i) a public health emergency as a result of the COVID-19 pandemic;
 - (ii) the public health emergency is in effect for the entire province of Newfoundland and Labrador; and
 - (iii) the public health emergency is in effect for a period of 14 days effective immediately;
- C. The public health emergency has been extended for 14-day intervals and is currently still in effect.
- D. The Chief Medical Officer of Health, pursuant to subsection 28(2) of the Public Health Protection and Promotion Act, may provide notice in any manner that can reasonably be expected to give actual notice;
- E. The Chief Medical Officer of Health, pursuant to section 28 of the **Public Health Protection and Promotion Act**, made Special Measures Order (General Alert Level 2) effective June 25, 2020;
- F. The Chief Medical Officer of Health believes that while special measures continue to be necessary for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency; in accordance with section 13 of the Public Health Protection and Promotion Act, that amendments to the restrictions set out in this Special Measures Order (General Alert Level 2) related to gatherings are

appropriate and are the least intrusive measures reasonably required in the circumstances to respond to the public health emergency,

Pursuant to section 28 of the Public Health Protection and Promotion Act, I, Dr. Janice Fitzgerald, Chief Medical Officer of Health HEREBY ORDER:

1. The Order No. 1 of the Special Measures Order (General – Alert Level 2) is hereby repealed and replaced with the following:

Gyms and fitness facilities, including yoga studios, indoor tennis, squash facilities and dance studios may operate at an occupancy limited to groups of no more than 100 people per room, provided that physical distancing may be maintained.

2. The Order No. 2 of the Special Measures Order (General – Alert Level 2) is hereby repealed and replaced with the following:

Cinemas, performance spaces and arenas may open provided that physical distancing may be maintained. Occupancy is limited to no more than 100 people per auditorium.

3. The Order No. 5 of the Special Measures Order (General – Alert Level 2) is hereby repealed and replaced with the following:

Bingo halls may open provided that physical distancing of 2 metres between patrons or bubbles seated at adjacent tables may be maintained. Occupancy is limited to no more than 100 people.

- **4.** The Order No. 6 of the Special Measures Order (General Alert Level 2) is hereby repealed and replaced with the following:
 - a. Gatherings of no more than 100 people are permitted provided the gathering is operated by a recognized business or organization and where physical distancing may be maintained. All other gatherings are limited to no more than 50 people provided physical distancing may be maintained.
 - b. Notwithstanding Order No. 6(a) above, gatherings in large venues including theatres and performing arts venues, community centres, other entertainment venues and sports venues, with a capacity of 500 people or more, may operate at a capacity higher than 100 where an operating plan has been approved by a Service NL Environmental Health Officer.
- 5. The Order No. 7 of the Special Measures Order (General Alert Level 2) is hereby repealed and replaced with the following:

Wakes are prohibited. Limited visitation is permitted provided physical distancing may be maintained with individuals outside of the household bubble. Funerals and burials are limited to no more than 100 people, including the officiant. Weddings and receptions, provided they are run by a recognized business or organization, are limited to no more than 100 people, including the officiant.

IT IS FURTHER ORDERED THAT:

- 1. This Order applies to all individuals and businesses operating in Newfoundland and Labrador.
- 2. This Special Measures Order (General Alert Level 2) (Gatherings Amendment) is effective August 24, 2020.
- 3. All other Orders contained in the Special Measures Order (General Alert Level 2) remains in full force and effect.
- **4.** All other Special Measures Orders and Exemption Orders remain in full force and effect.

TAKE NOTICE THAT:

- 1. Failure to comply with this order may result in an application to the Supreme Court, in accordance with section 42 of the **Public Health Protection and Promotion Act** to enforce the relevant provisions of this Order.
- A person who is subject to an order made by the Chief Medical Officer of Health may request that the Chief Medical Officer of Health reconsider the order by filing a written request for reconsideration within 7 days after the day on which the order is served on a person. A written request for review or reconsideration of this order shall include:
 - (i) the reasons for the request;
 - (ii) a summary of the facts relevant to the request;
 - (iii) whether the order should be revoked or how it should be varied; and
 - (iv) the contact information of the person making the request and shall be sent to the following address:

- 3. The Chief Medical Officer of Health shall review this Order no less than once every 5 days while the Order is in effect.
- **4.** This Order remains in effect during any review or reconsideration.
- 5. Failure to comply with this Order is an offence for which you may be liable on summary conviction in accordance with section 56 of the **Public Health Protection and Promotion Act**.
- **6.** For greater certainty, compliance with this Order is required in addition to and not in substitution for any requirement imposed by or under any applicable law.
