Special Measures Order Towns and Communities on the Baie Verte Peninsula Alert Level 3 Repeal Order

Made pursuant to Section 28 of the Public Health Protection and Promotion Act

October 7, 2021

TO: All individuals and businesses in the towns and communities along highway routes 410, 411, 412, 413, 414, 415, 416, 417, 418 and 419 on the Baie Verte Peninsula

WHEREAS:

- A. While a declaration of a public health emergency is in effect, the Chief Medical Officer of Health may do one or more of the special measures authorized under section 28 of the **Public Health Protection and Promotion Act** for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency;
- **B.** On March 18, 2020, the Minister of Health and Community Services, on the advice of the Chief Medical Officer of Health, declared:
 - (i) a public health emergency as a result of the COVID-19 pandemic:
 - (ii) the public health emergency is in effect for the entire province of Newfoundland and Labrador; and
 - (iii) the public health emergency is in effect for a period of 14 days effective immediately;
- C. The public health emergency has been extended for 14-day intervals and is currently still in effect;
- D. The Chief Medical Officer of Health, pursuant to subsection 28(2) of the Public Health Protection and Promotion Act, may provide notice in any manner that can reasonably be expected to give actual notice;
- E. The Chief Medical Officer of Health, pursuant to section 28 of the Public Health Protection and Promotion Act, made Special Measures Order (Alert Level 3) (Towns and Communities on the Baie Verte Peninsula) effective September 22, 2021;
- F. The Chief Medical Officer of Health believes that, while special measures continue to be necessary for the purpose of protecting the health of the population and preventing, remedying or mitigating the effects of the public health emergency, in accordance with section 13 of the Public Health

Protection and Promotion Act, the restrictions set out in the Special Measures Order (Alert Level 3) (Towns and Communities on the Baie Verte Peninsula) are no longer required in the circumstances to respond to the public health emergency,

Pursuant to section 28 of the Public Health Protection and Promotion Act, I, Dr. Rosann Seviour, Chief Medical Officer of Health HEREBY ORDER:

1. The Special Measures Order (Alert Level 3) (Towns and Communities on the Baie Verte Peninsula) is hereby repealed in its entirety.

IT IS FURTHER ORDERED THAT:

- 1. This Order applies to all individuals and businesses in the towns and communities along highway routes 410, 411, 412, 413, 414, 415, 416, 417, 418 and 419 on the Baie Verte Peninsula.
- 2. This Special Measures Order (Towns and Communities on the Baie Verte Peninsula Alert Level 3 Repeal Order) is effective as of 2:00 p.m. on October 7, 2021.
- 3. All other Special Measures Orders remain in full force and effect.

TAKE NOTICE THAT:

- 1. Failure to comply with this order may result in an application to the Supreme Court, in accordance with section 42 of the **Public Health Protection and Promotion Act** to enforce the relevant provisions of this Order.
- A person who is subject to an order made by the Chief Medical Officer of Health may request that the Chief Medical Officer of Health reconsider the order by filing a written request for reconsideration within 7 days after the day on which the order is served on a person. A written request for review or reconsideration of this order shall include:
 - (i) the reasons for the request;
 - (ii) a summary of the facts relevant to the request;
 - (iii) whether the order should be revoked or how it should be varied; and
 - (iv) the contact information of the person making the request and shall be sent to the following address:

- 3. The Chief Medical Officer of Health shall review this Order no less than once every 5 days while the Order is in effect.
- 4. This Order remains in effect during any review or reconsideration.
- 5. Failure to comply with this Order is an offence for which you may be liable on summary conviction in accordance with section 56 of the **Public Health**Protection and Promotion Act.
- 6. For greater certainty, compliance with this Order is required in addition to and not in substitution for any requirement imposed by or under any applicable law.
