Instructions

General

- A marriage licence is required for every marriage.
- Both parties must complete the form and at least one party must pick up the license in person and submit proof of age of both parties.
- Both parties to the marriage must present satisfactory evidence of identification (i.e. birth certificate, citizenship papers).
- Marriage may not be performed earlier than the fourth day after the date of licence.
- Issuers may not complete the Marriage Licence until:
 - (a) the prescribed fee has been paid (the fee is non-refundable);
 - (b) the required evidence has been filed (affidavits or the evidence filed with the application will not be returned);

Use of Surnames on Marriage

- A spouse by marriage may:
 - (a) use the surname of their spouse by marriage or a combination of each spouse's surname.
 - (b) revert to one's own surname or a previously acquired surname.

Applicant Under 19

- Any applicant who is under 19 years of age and is not widowed or divorced must file written consent of parent or legal guardian.
- Any applicant under 19 years of age must submit birth certificate or affidavit by parent or legal guardian swearing as to age of applicant.

Divorced Applicant

- If applicant is divorced, compliance must be made with the following requirements:
 - (1) If previously married and divorced in Canada, you will be required to present the original final decree or divorce certificate or a copy of the final decree or divorce certificate that dissolves or annuls the marriage be certified by a proper official.
 - (2) If you were divorced outside Canada, your final divorce documents are required, as well as a letter from a practicing NL Lawyer which states that the lawyer has examined your final divorce document and, in his/her opinion, you are free to marry in Newfoundland and Labrador.
 - (3) If your final divorce documents are in a language other than English or French, a certified translation is required in addition to the original documents. The certified translation must be completed by a certified translator. Please ask our staff for further information regarding the translation of documents.

It is the responsibility of the applicant to ensure that neither of the parties to the proposed marriage is within the prohibited degrees of consanguinity as printed below.

DEGREES OF CONSANGUINITY WHICH PROHIBIT A MARRIAGE BETWEEN TWO PEOPLE.

A man may not marry his – A woman may not marry her –

The relationships set forth in this table include all such relationships, whether by the whole or half blood or by order of adoption.
