Food - Annual Inspection Nov 02, 2023	Non-Critical Item(s)	901 - Other Non-Critical Item	Temperature booster to be increased in dishwasher; currently using 3 compartment sink method to manually wash dishes
		901 - Other Non-Critical Items	Floor to be repaired/replaced under dishwasher.
Food - Routine Inspection May 10, 2023	Non-Critical Item(s)	606 - Adequate mechanical ventilation	Professionally clean the fume hood canopy annually.
		702 - Non-food contact surfaces properly constructed, in good repair and clean	The flooring in the kitchen is in disrepair: under the dishwasher, sinks, work table, and next to the janitor's sink. Replace the damaged flooring.
		704 - Adequate protection from vermin and insect pests	Observed mice feces behind the cooking equipment and in the kitchen receiving room. Clean and disinfect areas immediately; use bleach/water (200 ppm or more) to disinfect. Increase pest control.
Food - Annual Inspection Jan 13, 2023	Non-Critical Item(s)	702 - Non-food contact surfaces properly constructed, in good repair and clean	Please replace ceiling tiles and repair leak. Repair leak under sink. Repair flooring. Repair dishwasher so it doesn't leak.

Food - Routine Inspection Jun 13, 2022	Non-Critical Item(s)	702 - Non-food contact surfaces properly constructed, in good repair and clean	The kitchen and receiving room flooring is in a state of disrepair: safety and sanitation issues. Replace all missing, damaged and worn out floor tiles.
		704 - Adequate protection from vermin and insect pests	Observed mice activity in the kitchen. Clean and disinfect areas of activity daily. Monitor for new activity every day and notify the school administration for the increased pest control measures.
Food - Annual Inspection Apr 13, 2022	Non-Critical Item(s)	702 - Non-food contact surfaces properly constructed, in good repair and clean	The kitchen flooring is in a state of disrepair; unable to properly clean and it is a safety issue. Replace the damaged kitchen flooring.
