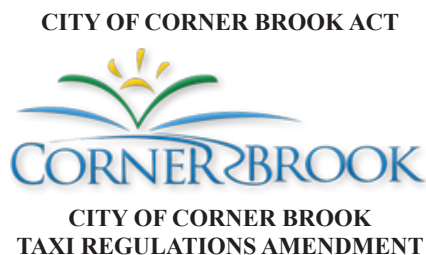

1. Paragraph 2(c) of the *Registered Nurses Regulations* is repealed.

2. Subsections 8(3) and (4) of the regulations are repealed.

3. Section 13 of the regulations is repealed and the following substituted:

Renewal of nurse practitioner licensure

13. A person applying for renewal of licensure as a nurse practitioner shall submit the documentation required in paragraph 8(1)(b) and paragraphs 12(1)(a) to (e).

4. Subsection 14(1) of the regulations is repealed and the following substituted:

Authority of nurse practitioner

14. (1) A nurse practitioner may

- (a) order the application of a form of energy permitted by the standards established by the council;
- (b) order laboratory or other tests permitted by the standards established by the council; and
- (c) prescribe a drug permitted by the standards established by the council.

Commencement

5. These regulations come into force on September 1, 2019.
