In general terms, the purpose of Development Regulations Amendment Number 699, 2019, is to amend the Commercial Mixed Use (CM) Zone, allowing for greater Building Height, Floor Area Ratio and Residential Density for buildings within the Churchill Square Retail Area. Parking requirements under Section 9 of the St. John's Development Regulations for the Churchill Square Parking Development Plan are also amended in order to allow residential parking within the designated retail area.
