#### ST. JOHN'S MUNICIPAL COUNCIL

#### NOTICE RESIDENTIAL PARKING AREA (AMENDMENT NO. 1-2020) BY-LAW

TAKE NOTICE that the St. John's Municipal Council has enacted the Residential Parking Area (AMENDMENT NO. 1-2020) By-Law.

The said By-Law was passed by Council on the  $24^{th}$  day of February, 2020, so as to remove the outdated fees and substitute a general fee provision instead.
