ENVIRONMENTAL ASSESSMENT REGULATIONS, 2003

VARIATION OF DEADLINE NOTICE

NOTICE IS HEREBY GIVEN that in accordance with the authority under section 3 of the *Temporary Variation of Statutory Deadlines Act*, the Minister of Municipal Affairs and Environment, on the advice of the Attorney General, hereby varies the following deadlines:

Under the Environmental Assessment Regulations, 2003.

- Section 4(1) The requirement for the minister to, in writing, advise the proponent of his or her decision under subsection 51(1) of the Act "not more than 45 days" after the registration of the undertaking, is varied to "not more than 165 days" after the registration of the undertaking.
- Section 5(7) The requirement for a committee to prepare the required guidelines and for the minister to issue the guidelines to the proponent "not more than 60 days" after the proponent has been notified of the determination under paragraph 51(1)(a) of the Act is varied to "not more than 180 days" after the proponent has been notified of the determination under paragraph 51(1)(a) of the Act and the requirement

for a committee to prepare the required guidelines and for the minister to issue the guidelines to the proponent "not more than 120 days" after the proponent has been notified of the determination under paragraph 51(1)(b) or 54(5)(a) of the Act is varied to "not more than 240 days" after the proponent has been notified of the determination under paragraph 51(1)(b) or 54(5)(a) of the Act.

1. S.2 Amdt. Registration requirements

1. Section 2 of the *Social Workers Regulations* is amended by adding immediately after subsection (2) the following:

(3) Notwithstanding paragraphs (1)(e) and (f), the registrar may register an applicant who does not provide a Certificate of Conduct and a Vulnerable Sector Check where

- (a) the applicant meets all other requirements for registration; and
- (b) the registrar is satisfied that a Certificate of Conduct and a Vulnerable Sector Check cannot be obtained within a reasonable period of time.

(4) Notwithstanding subsection (2), the registrar may register an applicant that is currently or was previously licensed or registered to practise social work in another jurisdiction and who does not provide a letter of good standing from the other jurisdiction where

(a) the applicant meets all other requirements for registration;

- (b) the applicant provides a declaration stating that he or she
 - (i) has requested a letter of good standing from the licensing or registration body of the other jurisdiction, and
 - (ii) is not or has never been the subject of investigative or disciplinary proceedings in the other jurisdiction or provides the particulars of any investigative or disciplinary proceedings; and
- (c) the registrar is satisfied that a letter of good standing from the other jurisdiction cannot be obtained within a reasonable period of time.
