(b) on sand, gravel, rock, mineral soil or other non-combustible materials if

- (i) the fire is located at a distance of not less than one metre from any flammable material,

- (ii) the space directly above the one metre area around the fire is at least 3 metres from any overhanging trees,
- (iii) the fire does not exceed 0.5 metres in height and 0.5 metres in width, and
- (iv) the person has access to at least 8 litres of water or a shovel at all times.
