INSURANCE ADJUSTERS, AGENTS AND BROKERS ACT

VARIATION OF DEADLINE NOTICE

Under the Insurance Adjusters, Agents and Brokers Act, RSNL 1990, c. 1-9:

Subsection 31(1) The requirement that funds held in trust for the insurer shall be paid over to the insurer pursuant to subsection 31(1) "within 15 days" after a written demand is made is varied to "within 30 days" if the written demand is made on or after the publication of this Notice and before October 31, 2020.
