Coyote -Newfoundland and Labrador **16.** The open season for the shooting of coyote on the Island of Newfoundland and in Labrador under a coyote shooting licence shall be September 12, 2020 to July 15, 2021.

Coyote - Labrador

- 17. (1) In this section, "fur management zone" means the fur management zones described in Schedule B of the Fur Bearing Animals and Coyote Trapping and Shooting Order, Newfoundland and Labrador.
- (2) The open season for the trapping and shooting of coyote in Labrador in the following fur management areas shall be
 - (a) October 15, 2020 to March 31, 2021 in the Labrador North Fur Zone; and
 - (b) November 1, 2020 to March 20, 2021 in the Labrador South Fur Zone.

Coyote -Newfoundland **18.** (1) In this section, "fur management area" means the fur management areas described in Schedule A of the Fur Bearing Animals

and Coyote Trapping and Shooting Order, Newfoundland and Labrador.

- (2) The open season for the trapping and shooting of coyote on the Island of Newfoundland in all fur management areas shall be October 20, 2020 to February 1, 2021.
- 19. The Open Seasons Hunting and Trapping Order, 2019-2020, Newfoundland and Labrador Regulation 55/19, is repealed.
