MECHANIC'S LIEN ACT

NOTICE TO EARLY RELEASE OF MECHANIC'S LIEN HOLDBACK PURSUANT TO SECTION 12 OF THE MECHANIC'S LIEN ACT, RSNL 1990, CM-3 (THE "ACT")
