#### CITY OF CORNER BROOK ACT



#### RECREATIONAL VEHICLE REGULATIONS, 2021

PURSUANT TO the powers vested in it under Section 201 and 202 of the CITY OF CORNER BROOK ACT, R.S.N.L. 1990, C. C-15, as amended, and Section 10 of the MOTORIZED SNOW VEHICLE AND ALL-TERRAIN VEHICLE ACT, R.S.N.L. 1990 C M-20 as amended, and all other powers it enabling, the Corner Brook City Council repealed and replaced CITY OF CORNER BROOK RECREATIONAL VEHICLE REGULATIONS, 2019. The new regulation may be cited as CITY OF CORNER BROOK RECREATIONAL VEHICLE REGULATIONS, 2021 and includes the following changes:

- Revises Schedule A to include Lundrigan Drive;
- Adds the ability for the City to issue Access Permits to residents;

- Enables the extensions of the riding season;
- Enhances enforcement measures.

These regulations will have effect from the date of publication in *The Newfoundland and Labrador Gazette*.
