## THIRD PARTY AND DIGITAL SIGNAGE REGULATIONS, 2021

Pursuant to the powers vested in it under Section 249, 250, 251, 252, 438 and 439 of the CITY OF CORNER BROOK Act, R.S.N.L. 1990, c. C-15 and all other enabling power, the Council of the CITY OF CORNER BROOK hereby repeals the CITY OF CORNER BROOK THIRD PARTY AND DIGITAL SIGNAGE REGULATIONS, 2017. The new regulation may be cited as CITY OF CORNER BROOK THIRD PARTY AND DIGITAL SIGNAGE REGULATIONS, 2021.

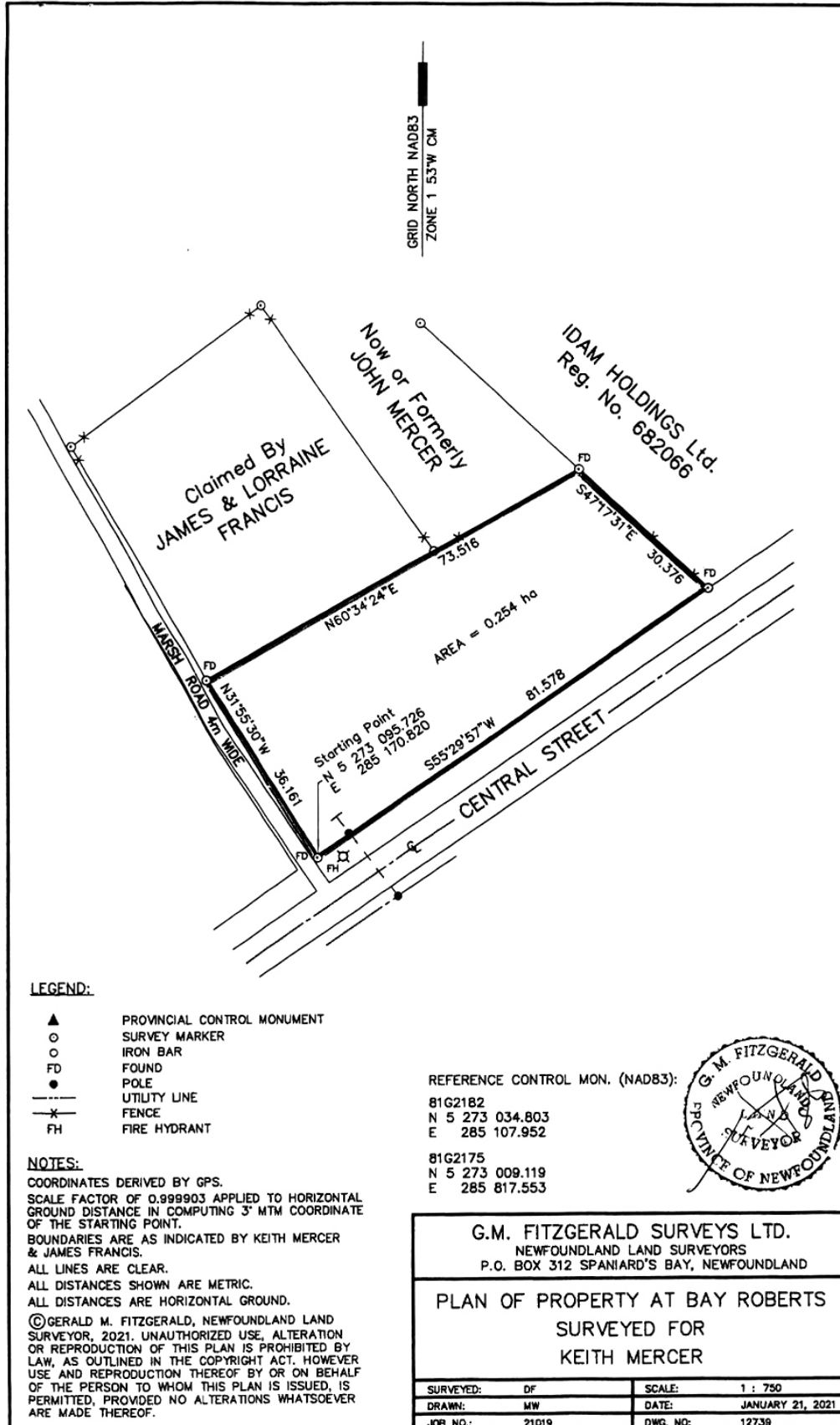
