(3) Unless an exemption is made by the DFNL, separate permit numbers shall be obtained for each shipment of milk outside the province.

(4) A person holding a licence issued under subsection (1) shall not import pre-packaged milk into the province in an amount greater than 3 percent of the amount that person processes or produces within the province in any given month or each month.

(5) Any person who contravenes subsection (4) is liable to either or both of the following penalties:

(a) a penalty per litre over the permitted amount of prepackaged milk equal to the difference between the export price of milk determined under subsection 24(1) and the minimum price for milk under section 22; or
