EMERGENCY SERVICES ACT

Declaration of Emergency Made pursuant to Section 9 of the Emergency Services Act

WHEREAS on August 6, 2022, pursuant to the authority that exists under section 9(1) of the *Emergency Services Act*, an emergency was declared in the areas of Grand Falls-Windsor, Bishop's Falls and the Connaigre Peninsula;

AND WHEREAS the forest fire along the Bay d'Espoir Highway now has a high potential to reach the community of Botwood;

AND WHEREAS provincial forest fire services are working diligently to suppress and control the spread of this and other forest fires but the current weather conditions are conducive to extreme fire behavior;

AND WHEREAS based on the above, I reasonably believe the forest fires burning in the central area of the Island of Newfoundland remain of serious concern and necessitates further immediate and prompt coordination of action;

THEREFORE pursuant to the authority that exists under section 9(1) of the *Emergency Services Act*, I DECLARE an emergency in the area of Botwood.

AND THEREFORE pursuant to section 9(3) of the Emergency Services Act, because an emergency has been declared, I:

- (a) direct that the Director of Emergency Services take charge of emergency operations within the area, to assess the situation and to report immediately to me regarding any measures to be taken to deal with the emergency;
- (b) authorize the Director of Emergency Services to co-ordinate the activities of all provincial and municipal services in the area and to engage personnel as required to assist in the provision of those services;

- (c) authorize the Director of Emergency Services to acquire those supplies and equipment the director considers necessary to respond to the emergency or to protect the health and well-being of those persons, property and the environment impacted by the emergency; and

Declaration of Emergency Made pursuant to Section 9 of the Emergency Services Act

WHEREAS the central area of the island of Newfoundland in the Province of Newfoundland and Labrador is currently facing a serious situation as a result of current forest fires;

AND WHEREAS one forest fire along the Bay d'Espoir Highway is causing closures of the Bay d'Espoir Highway resulting in the isolation of a number of communities on the Connaigre Peninsula;

AND WHEREAS a second forest fire along the Bay d'Espoir Highway has a high potential to reach the communities of Grand Falls-Windsor and Bishop's Falls;

AND WHEREAS provincial forest fire services are working diligently to suppress and control the spread of these forest fires but the current weather conditions are conducive to extreme fire behavior;

AND WHEREAS based on the above, I reasonably believe the forest fires burning in the central area of the Island of Newfoundland are of serious concern and necessitate immediate and prompt coordination of action;

THEREFORE pursuant to the authority that exists under section 9(1) of the *Emergency Services Act*, I DECLARE an emergency in the areas of Grand Falls-Windsor, Bishop's Falls, and the Connaigre Peninsula.

Forest Fire Ban Proclamation, 2022 under the Forestry Act

1. (1) Paragraphs 2(1)(c) and (d) of the Film and Video Industry Tax Credit Regulations are repealed and the following substituted:

- (c) "eligible employee" means an employee who was resident in the province on
 - (i) December 31 of the taxation year, or
 - (ii) December 31 of the year immediately preceding the taxation year;
- (d) "eligible individual" means an individual, other than a trust or estate, who was resident in the province on
 - (i) December 31 of the taxation year, or
 - (ii) December 31 of the year immediately preceding the taxation year;
- (2) Subparagraph 2(1)(f)(i) of the regulations is amended by deleting the words "first script stage" and substituting the words "production commencement time".
- (3) Subparagraph 2(1)(f)(ii) of the regulations is amended by deleting the words "beginning of the first contracted script stage" and substituting the words "production commencement time".
- (4) Subparagraphs 2(1)(g)(i) and (ii) of the regulations are repealed and the following substituted:
 - (i) government equity investment provided by the Canada Media Fund, Telefilm Canada or Newfoundland and Labrador Film Development Corporation that is recoupable or repaid, and
 - (ii) an amount received or receivable under the Canada Media Fund Licence Fee Program;
- (5) Paragraph 2(3)(d) of the regulations is amended by deleting the word "cameraman" and substituting the words "camera operator".
- 2. Subsection 7(2) of the regulations is amended by deleting the words "and before January 1, 2022".
 - 3. Section 9 of the regulations is repealed.

Commencement

4. Section 2 of these regulations is considered to have come into force on January 1, 2022.
