#### ST. JOHN'S MUNICIPAL COUNCIL NOTICE ST. JOHN'S HERITAGE DESIGNATION BY-LAW (AMENDMENT NO. 1-2022)

TAKE NOTICE that the ST. JOHN'S MUNICIPAL COUNCIL HAS ENACTED THE ST. JOHN'S HERITAGE (AMENDMENT NO. 1-2023) BY-LAW.

The said By-Law was passed by Council on the 16<sup>th</sup> day of January, 2023, so as to replace the current Schedule "A" – Terms of Reference for the Built Heritage Experts Panel with an updated Schedule "A" and the current Schedule "C" – Heritage Buildings and Maps with an updated Schedule "C" removing 154 New Cove Road (Bryn Mawr) from the schedule.
