A PROCLAMATION

WHEREAS in and by section 26 of An Act to Amend the *Wild Life Act*, Statutes of Newfoundland and Labrador 2022 Chapter 26 (the "Act"), it is provided that the Act comes into force on a day or days to be proclaimed by the Lieutenant-Governor in Council;

AND WHEREAS it is deemed expedient that the Act shall now come into force with the exception of subsection 1(3);

**(2) Paragraph 2(l) of the regulations is repealed and the following substituted:**

(1) "licensed guide" means the holder of a guide's licence issued to the holder and valid under the *Guides Regulations, 1998*;

**(3) Section 2 of the regulations is amended by adding immediately after paragraph (o) the following:**

(o.01) "prepared meal" means a meal that is either cooked or prepared in another manner that does not require further preparation before it can be consumed;

**2. Subsection 3(2) of the regulations is amended by deleting the words "his or her" and substituting the words "the person's".**

**3. (1) Subsection 6(1) of the regulations is amended by deleting the words "he or she" and substituting the words "the person".**

**(2) Subsection 6(3) of the regulations is amended by deleting the words "his or her tag" and substituting the words "a tag issued with the licence".**

(d) the stock on hand at the end of the month.
