#### Overview

The Board is established under subsection 25(1) of the **Public Safety Act** (the Act) to hear appeals from persons who may be aggrieved by a decision of one of the Chief Inspectors related to the operations of various technical safety systems (e.g. electrical, boilers/pressure vessels, elevating devices). The Board, after hearing an appeal, may confirm, revoke or vary the notice, order, decision or action of the Chief Inspector. The Board is comprised of five members appointed by the Lieutenant-Governor in Council, upon recommendation by the Minister of Digital Government and Service NL, and meets only when an appeal has been filed pursuant to section 26 of the Act.

#### **Vision**

The Board works to ensure the fair and equitable application of its mandate as outlined in legislation.

#### **Mandate**

The Board is an independent, quasi-judicial body that has the function of hearing and adjudicating an appeal. It meets when it has received an appeal pursuant to section 26 of the Act and is empowered to uphold, revise and/or revoke an order or action by the Chief Inspector. Decisions by the Board are based on review of the written and oral submissions and documents. The Board's decisions may be appealed to the courts.

### **Report on Performance**

This Report outlines the Board's activities from April 1, 2022 to March 31, 2023, including the objectives achieved as outlined in the 2020-23 Activity Plan.

#### Objective:

By March 31, 2021, 2022 and 2023, the Public Safety Appeal Board will have processed all appeals it has received in accordance with the requirements of the Act.

#### Indicators:

- Appeal received from the Department within 15 days of application.
- Appellant given at least 10 days' notice regarding hearing of an appeal.
- Appeals commenced not more than 90 days after notice in writing has been received by the chairperson under subsection 26(2).
- Appeal decisions rendered within 180 days after notice in writing has been received by the Chairperson under subsection 26(2).

#### **Results Achieved:**

The Board meets only when an appeal has been filed pursuant to section 26 of the Act. No appeals were filed in the fiscal year 2022-23.

## **Opportunities and Challenges**

The Board has opportunity to provide a venue for appeals to be brought forward, considered and decided on in a timely manner and to maintain and enhance communication with Newfoundlanders and Labradorians. This is in conjunction with advising the Minister of Digital Government and Service NL regarding the mandate of the Act and any other topics, challenges and opportunities for improvement across the region. For fiscal year ending 2023 the Board has experienced no challenges or restrictions that prevented completing our mandate.
