Schedule of Fees Prescribed by the Minister of Government Services Registry of Deeds

This S	chedule may be cited as The Registration of Deeds Prescribed Fees.			
(1) The Registrar shall collect and pay into the Consolidated Revenue Fund the following fees:				
a. for registering a conveyance, assignment or other document

	ii.	when the actual value of the property passing or affected by the document exceeds five hundred dollars		
b.		plus forty cents for each additional one hundred dollars or part of one hundred dollars;		
	i.	for registering a mortgage when the amount secured does not exceed five hundred dollars		
	ii.	for registering a mortgage when the amount secured exceeds five hundred dollars		
		plus forty cents for each additional one hundred dollars or part of one hundred dollars;

(2)	A person is not liable to pay for the registration of a mortgage, charge, floating charge, or specific or floating mortgage or charge of chattels referred to in subsection (1) a fee of more than five thousand dollars.				
(3)	The Registrar shall not register an instrument unless the proper fee is first paid.				
(4)	A fee is not payable on the registration of an instrument registered by or on behalf of the Crown.				
(5)	A fee is not payable on the registration of an instrument registered by or on behalf of a non-profit airport authority, with respect to property transferred to it under the National Airport Policy.
