Tails must be used in accordance with Beavertails shelf-life policy. All expired and freezer burnt tails discarded at time of inspection. B) Numerous freezer burnt products observed at time of inspection. Heavy ice buildup observed on frozen fruit products, holes in fruit bags, heavy ice buildup on cheese, etc. All products discarded at time of inspection.
	<b>Non-Critical Item(s)</b>	503 - Proper Storage of Frozen Food Items	Freezer must be re-organized and not overstocked to allow circulation and prevent freeze/thaw and freezer burn
		704 - Adequate protection from vermin and insect pests	Door must be closed at all times to prevent entry of rodents.
