Food - Annual Inspection Jul 05, 2023	Critical Item(s)	202 - Adequate Handwashing Facilities Supplied and Accessible	All hand wash sinks were not supplied with both soap and paper towel in dispensers. Kitchen handwash sink was not easily accessible. Ensure all handwash sinks are fully supplied and accessible for proper handwashing.
		404 - Toxic Chemicals Properly Labeled, Stored and Used to Prevent Food Contam.	Appropriate sanitizer/disinfectant was not being used in the kitchen or on customer tables at the time of inspection. Ensure Bleach mixture is used on all food contact surfaces and is mixed to the proper concentration. All spray bottles must also be labeled correctly to prevent cross contamination.
	Non-Critical Item(s)	503 - Proper Storage of Frozen Food Items	Large walk-in freezer is very unorganized and in need of repair. Scrap off and re-surface any chipped paint. Organize freezer so that raw meats are separate from frozen veg.
		702 - Non-food contact surfaces properly constructed, in good repair and clean	General cleaning and sanitizing needed under cooking equipment. Build up of grease under fryers at the time of inspection.

Food - Annual Inspection Mar 30, 2022	Non-Critical Item(s)	601 - Food contact surfaces properly constructed or located, acceptable material	Re-surface shelving, walls, and ceiling in large walk- in cooler and freezer. Paint peeling at time of inspection along with rusty shelving.
