GREETING;

A PROCLAMATION

WHEREAS in and by section 31 of "An Act to Provide for the Organization and Administration of Emergency Services in the Province" SNL2008 cE-9.1 (the "Act") it is provided that the Act shall come into force on a day or days to be fixed by Proclamation of Our Lieutenant Governor in Council;

AND WHEREAS it is deemed expedient that the Act shall come into force on the date set below;

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland and Labrador, do by this our Proclamation declare and direct that "An Act to Provide for the Organization and Administration of Emergency Services in the Province" SNL2008 cE-9.1, shall come into force on the May 1, 2009.

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.
