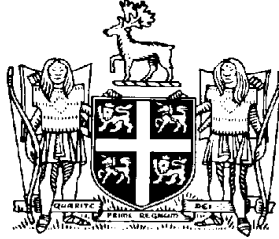

GREETING;

A PROCLAMATION

WHEREAS in and by section 44 of “*An Act Respecting Architects and the Provision of Architectural Services*,” SNL2008 cA-15.1 (the “Act”) it is provided that the Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant Governor in Council;

AND WHEREAS it is deemed expedient that the Act shall come into force.

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland and Labrador, do by this our Proclamation declare and direct that “*An Act Respecting Architects and the Provision of Architectural Services*” SNL2008 cA-15.1, shall come into force on the date of publication of this proclamation in *The Newfoundland and Labrador Gazette*.
