GREETING;

A PROCLAMATION

WHEREAS in and by section 11 of "An Act to Provide for the Recovery of Tobacco Related Health Care Costs," SNL 2001 cT-4.2 (the "Act") it is provided that the Act shall come into force on a day to be fixed by Proclamation of Our Lieutenant Governor in Council;

AND WHEREAS it is deemed expedient that the Act shall now come into force;

NOW KNOW YE, THAT WE, by and with the advice of Our Executive Council of Our Province of Newfoundland and Labrador, do by this our Proclamation declare and direct that "An Act to Provide for the Recovery of Tobacco Related Health Care Costs," SNL 2001 cT-4.2 shall come into force on February 7, 2011.

OF ALL WHICH OUR LOVING SUBJECTS AND ALL OTHERS whom these Presents may concern are hereby required to take notice and to govern themselves accordingly.
