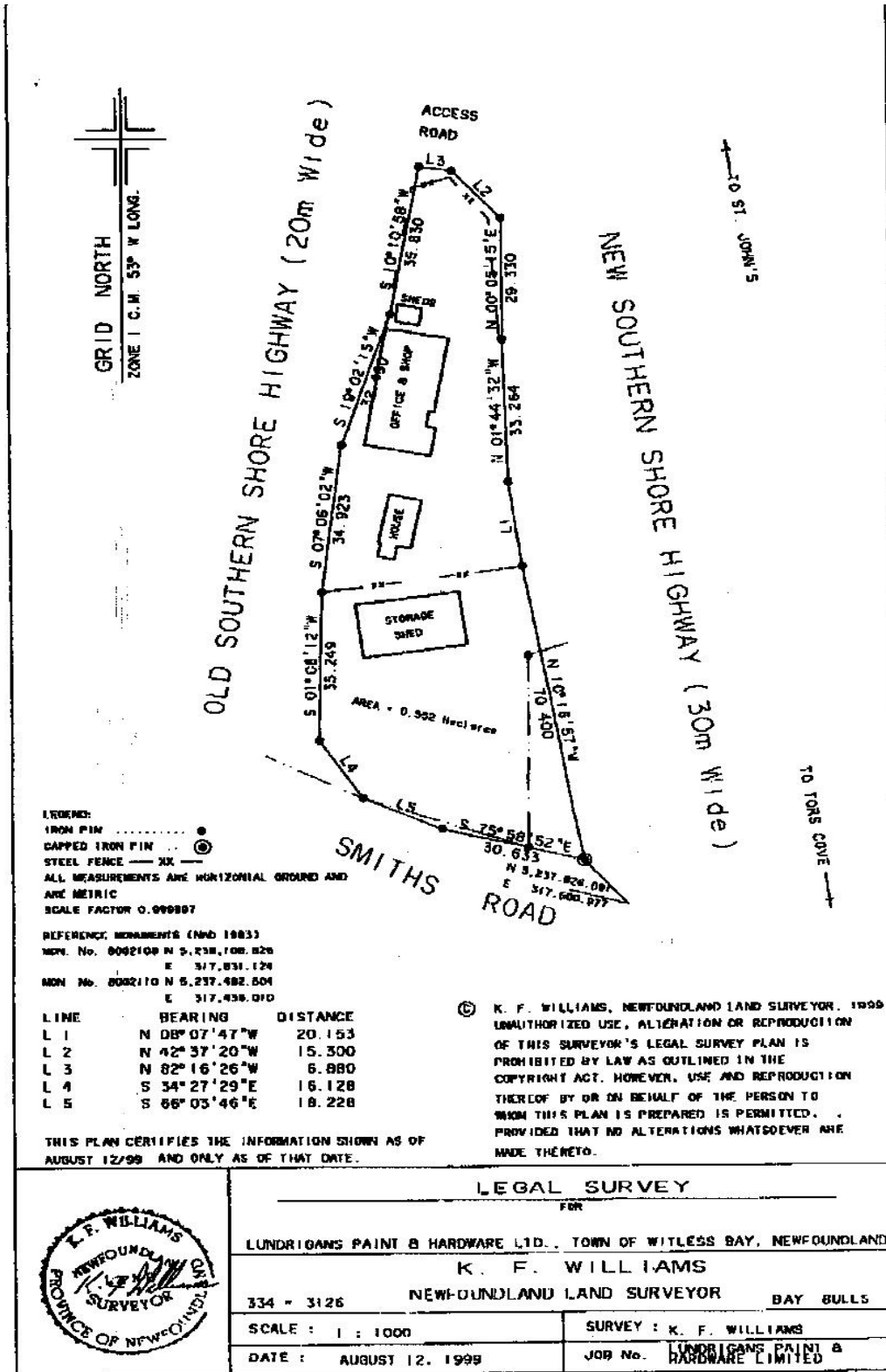

ELECTIONS ACT, 1999**REPORT OF THE CHIEF ELECTORAL OFFICER
ON
ELECTION FINANCES FOR
THE TRINITY NORTH BY ELECTION
APRIL 25, 2000****TRINITY NORTH BY-ELECTION FINANCE REPORT**

Part III of the *Elections Act, 1991* was proclaimed into force on October 1, 1993. In addition to outlining the powers and duties of the Chief Electoral Officer with respect to Election Financing the *Act* establishes a regulatory framework for campaign financing and the reporting of financial information applicable to elections and by-elections in this Province.

Section 304 of the *Elections Act* requires candidates in a by-election and parties that received contributions or made expenditures in relation to the by-election to file with the Chief Electoral Officer a financial statement of income and expenses relating to the election. All three candidates who participated in the Trinity North by-election together with the Liberal Party filed audited financial statements of campaign income and expenses by the October 25, 2000 filing deadline. These statements have been examined and reviewed by the Chief Electoral Officer with a view to determining compliance by the parties involved with the provisions of Part III of the *Elections Act*. With respect to this review relatively few and minor compliance issues arose and all have been resolved to the satisfaction of the Chief Electoral Officer.

Section 310 of the *Elections Act, 1991* places a limitation on the amount of election expenses permitted by political parties and candidates in an election. The allowable limit on eligible expenses for the Trinity North by-election was set by the Chief Electoral Officer at \$30,729. It was based on the number of eligible voters on the official voter's list used for the by-election (9426) multiplied by an inflation adjusted factor of \$3.260 per voter. Neither of the reporting entities had expenditures outside of the established limits.

Two of the three candidates in the by-election received at least fifteen percent of the popular vote cast in the district. As a result the candidate's campaigns were entitled to receive an election expense reimbursement. The payment is calculated to be 1/3 of eligible allowable campaign expenses up to a maximum of 1/3 of the district's expenditure limit. Candidate Stagg's campaign received \$6,717 under this formula while Candidate Wiseman's campaign was reimbursed \$8,536.

Section 313 of the *Elections Act* requires that campaign surpluses created either from political contributions or expense subsidies be, in the case of a candidate whose political affiliation appears on the ballot, remitted to his or her party, and in all other cases be remitted to the Chief Electoral Officer who shall hold the money in trust on behalf of the candidate to be used in the next general or by-election.

The following tables present a summary of the financial information filed relating to the Trinity North by-election. The actual financial statements on which the summaries are based are public documents and may be viewed at the Office of the Chief Electoral Officer during normal business hours.
