3. Rezone the Kinsman's Club at the corner of Lemarchant Street and Masonic Avenue to the Residential Medium Density Use Zone;
4. Rezone lands between Cotter's Road and Earle's Lane to the Residential Medium Density Use Zone; and
5. Add conditions to the requirements for sideyards in the Commercial -General use zone.

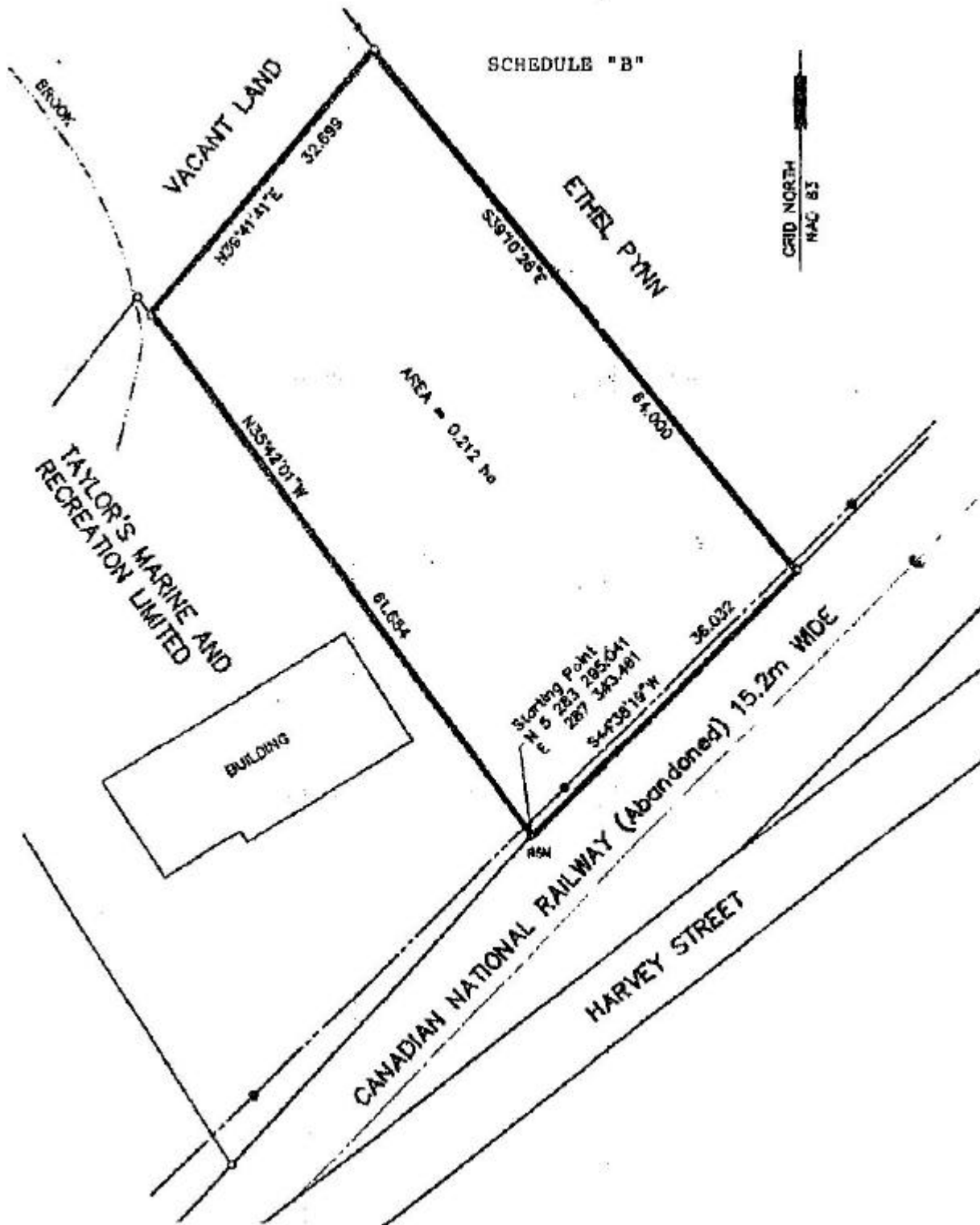

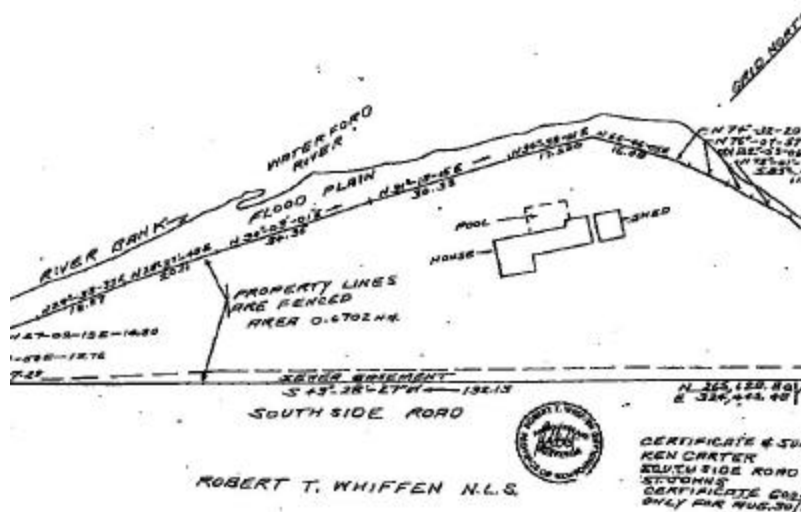
