### NOTICE OF AMENDMENT

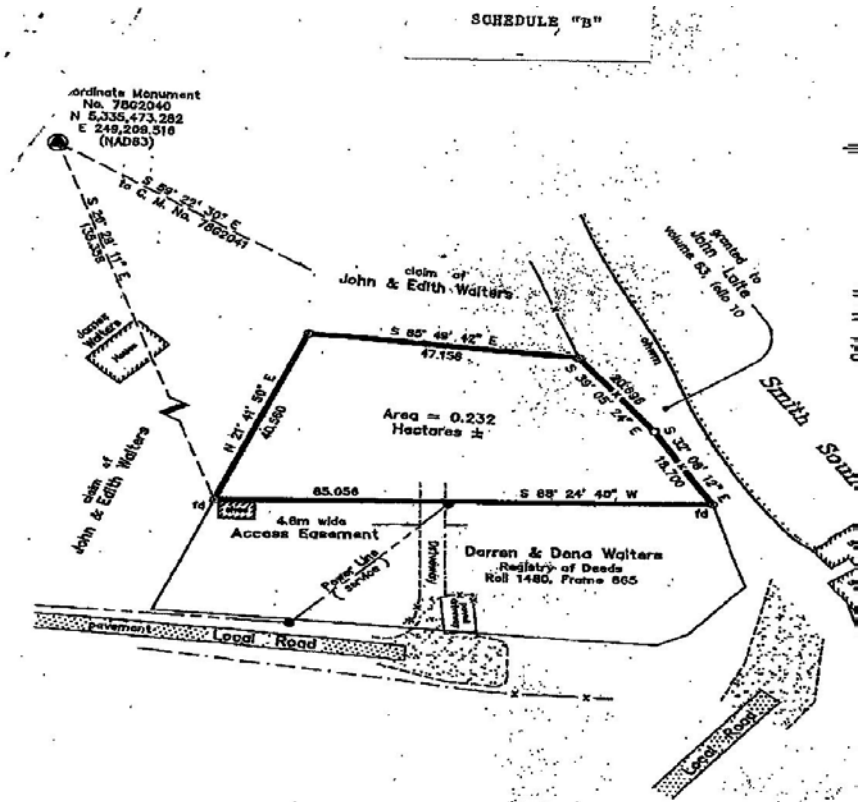
