DEVELOPMENT REGULATIONS AMENDMENT
NO. 4 & 5, 2002

TAKE NOTICE that the Town of Arnold's Cove Municipal Plan Amendment No. 1 & 2, 2002 and Development Regulations Amendment No. 4 & 5, 2002, adopted on the 22nd day of May, 2002, and approved on the 10th day of June, 2002 has been registered by the Minister of Municipal and Provincial Affairs.

In general terms, the purpose of Municipal Plan Amendment No 1, 2002 is to redesignate land along the east side of Main Road to the Mixed Development Use designation from the Commercial-industrial Land Use designation. The purpose of Municipal Plan Amendment No. 2, 2002 is to redesignate land to the northwest of the Main Road adjacent Lockyer's Convenience to the Mixed Development land use designation and add a policy to the Municipal Plan to allow residential development on "backlots" subject to a number of conditions.

In general terms the purpose of the corresponding Development Regulations Amendment No. 4 & 5 is to rezone the areas to the Mixed Development Use Zone. The amendment also adds conditions to the Mixed Development Use Zone Table to provide for residential development on "backlots".

The Arnold's Cove Municipal Plan Amendment No. 1 & 2, 2002 and Development Regulations Amendment No. 4 & 5, 2002 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of the Municipal Plan and Development Regulations Amendments may do so at the Town Office, during normal working hours.

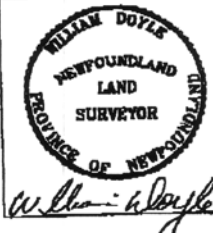
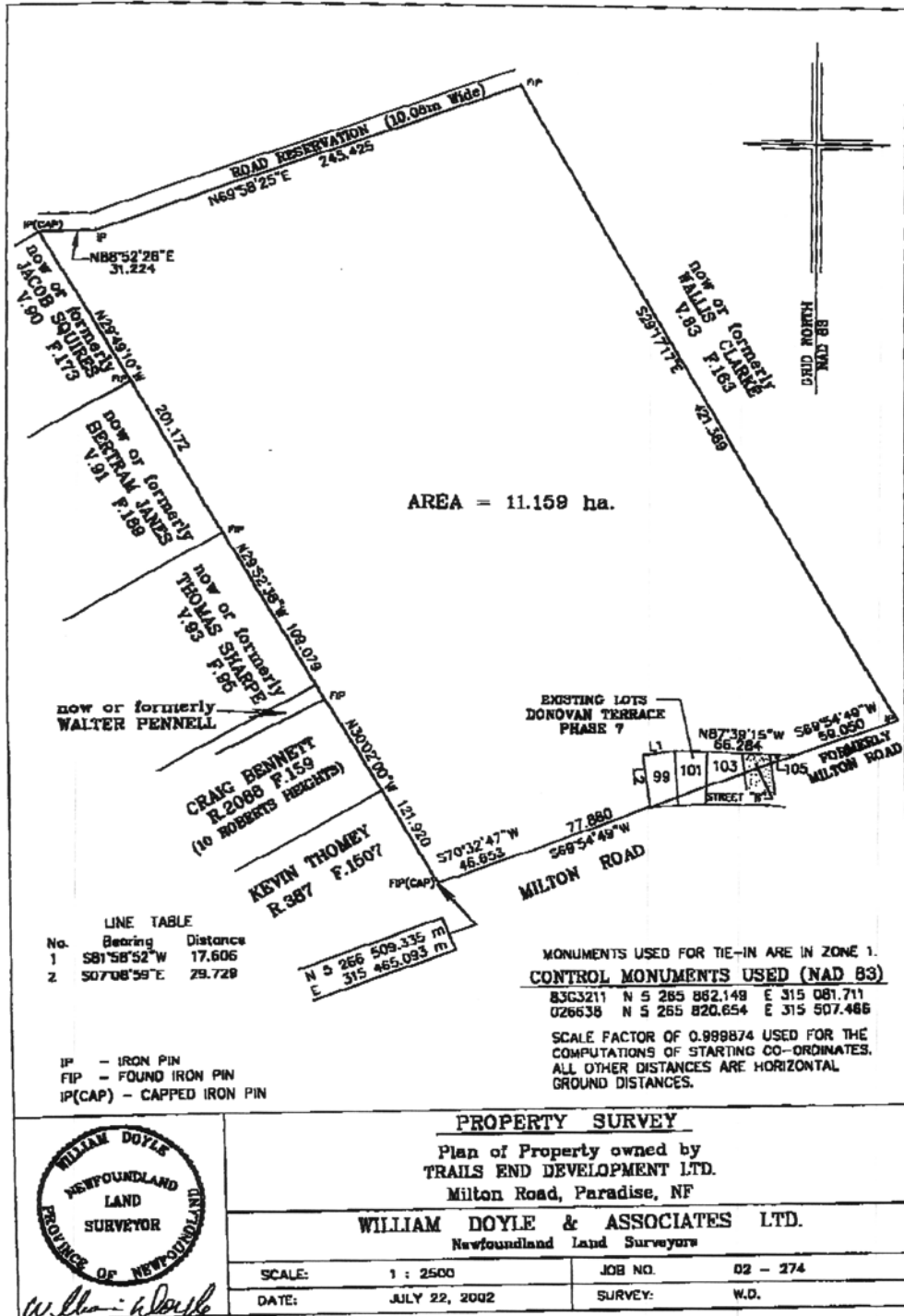

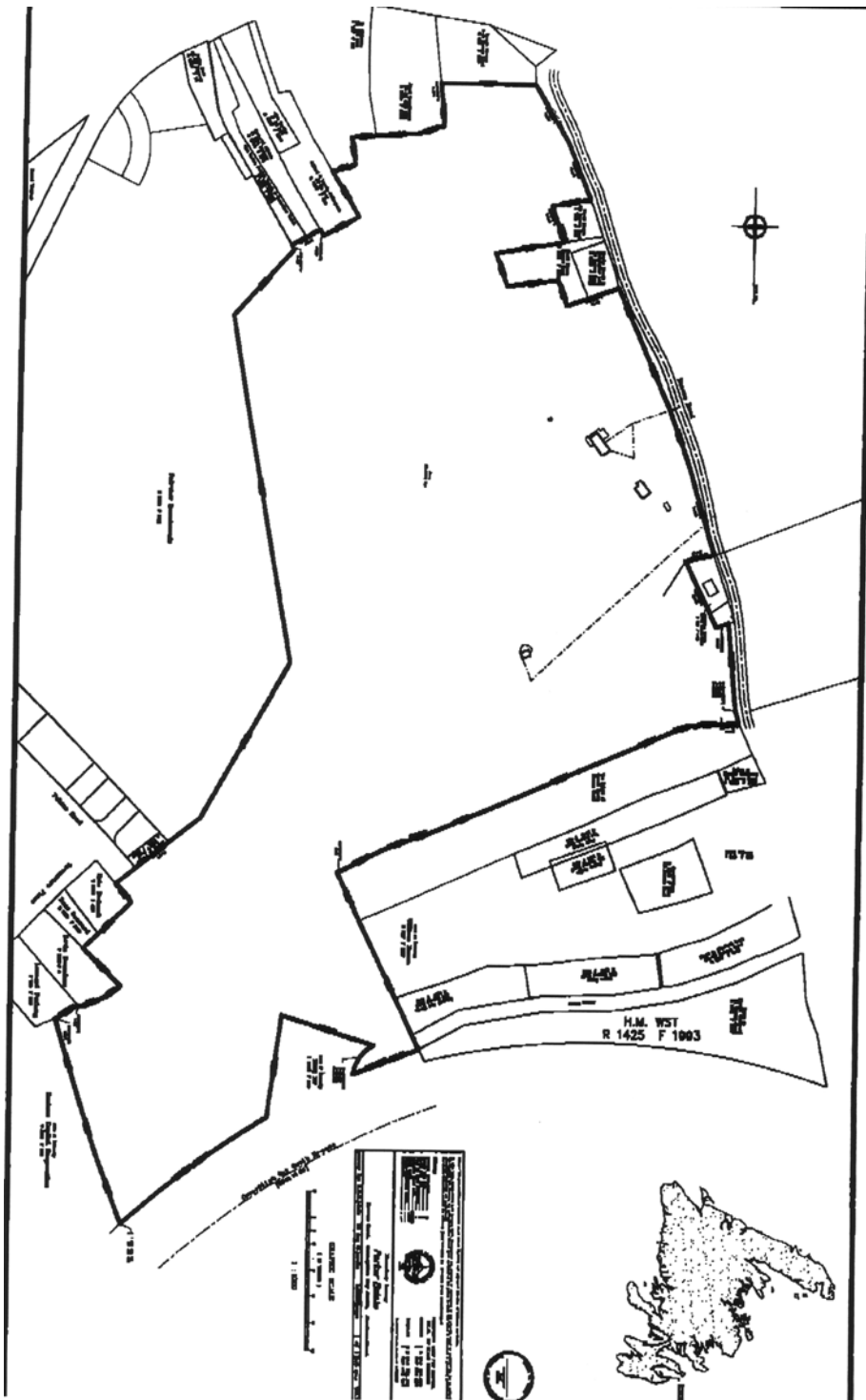

(b) for tobacco, \$0.035 per gram.

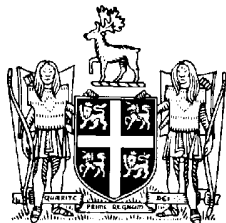
