TAKE NOTICE that the City of St. John's Development Regulations Amendment No. 261, 2002, adopted on the 5th day of August, 2002, and approved on the

19th day of August 2002, has been registered by the Minister of Municipal and Provincial Affairs.

In general terms the purpose of St. John's Development Regulations Amendment No. 261, 2002, is to:

Amend Section 10.32.3(d), Section 10.36.3(e), Section 10.37.3(e), and Section 10.38.3(d) to read:

“Side Yard (minimum)
6 m”

1. Amend Section 10.33.3 and Section 10.35.3 to read:

“(a) Accessory Dwelling Unit
Side Yard (minimum) 6m”

2. Amend Section 8.3.6(3) by the addition of:

“(e) accessory Buildings, when located in areas not provided with regular municipal water and sewer services, shall be erected at least 6 metres from any Side or Rear Lot Line.”
