1. Introduction

The Honorable Lloyd G. Matthews, Minister of Mines and Energy (the Minister), hereby makes a Request for Bids for the issuance of onshore exploration permits. This request for bids is made pursuant and subject to the *Petroleum Regulations* under the *Petroleum and Natural Gas Act*.

This request is in respect of the thirteen (13) parcels as described under Schedule "A" and shown on the attached map. Each parcel represents a potential exploration permit.

2. Submission of Bids

- a) All bids submitted in response to this request for bids must be in a sealed envelope clearly marked as follows:

- b) This request for bids will close at 4:00 p.m., Newfoundland Standard Time, on December 13, 2002. Bids must be received at the above address prior to the time of closing. Bids received after this time will not be considered.
- c) Bids are to be submitted in accordance with the Request for Bids Sheet attached as Schedule "C". All information must be completed on the Bid Sheet. In addition, the representative, or designated representative as the case may be, shall sign the Application for a Permit attached as Schedule "B". A brief statement on the bidder's petroleum exploration and development experience, including a company profile, should be attached to the Application for a Permit.
- d) Each bid shall only contain the information required on the bid sheet. Conditional bids will not be accepted.
- e) Submissions received in response to this request for bids will not be returned.

3. Bid Assessment

- a) For the purpose of assessing and selecting a bid for all parcels, the single criterion to be used is a dollar value of the work obligation commitments to be undertaken by the bidder(s).
- b) These work obligation bids shall be expressed in terms of the total dollar amount of money to be expended on a parcel for the primary term of the exploration period (5 years).
- c) For the purpose of section 27 of the *Petroleum Regulations*, the total bid shall be divided into annual work obligations of twenty percent (20%) during the primary term of the exploration permit.
- d) In the event of two or more identical bids for a parcel, those "tied" bidders shall be notified of such and requested to re-submit bids in accordance with the Minister's instructions.
- e) If acceptable to the Minister, the highest work obligation bid shall be selected. Amounts acceptable may vary from parcel to parcel.
- f) The Minister may require a bidder to submit additional information in order to assess the bid.
- g) The Minister shall not consider a bid unless it is submitted in accordance with the *Petroleum Regulations* and this Request for Bids. The Minister is under no obligation to accept any bid received.

4. Bid Deposits

- a) For all parcels, the bid must be accompanied by a certified cheque in the amount of \$1000.00 made payable to the Newfoundland Exchequer Account.
- b) Upon the announcement of bid results, the bid deposits of unsuccessful bidders will be returned, without interest, as soon as possible.

- c) Bid deposits of successful bidders, following receipt of a security deposit (defined below), shall be credited towards payment of a \$1000.00 issuance fee per exploration permit.
- d) Bid deposits shall be forfeited in favor of the Crown where successful bidders fail to post the required security deposit or submit the deposit in a proper manner. In such cases, the bid is also revoked.
- e) Where a bid is revoked, the Minister may accept, by notification, the next highest bidder.

5. Security Deposits

- a) Upon notification of a successful bid, the bidder shall submit, within twenty-one (21) days of receipt of notification, a security deposit in the amount of twenty percent (20%) of the bid.
- b) The security deposit shall be in the form of a certified cheque, payable to the Newfoundland Exchequer Account or an irrevocable letter of credit from a bank named in Schedule I of the *Bank Act (Canada)*
- c) A credit against the security deposit shall be made following approval of eligible work expenditures. These work expenditures require pre-approval and shall be based on competitive rates with reasonable allowances for mobilization costs, terrain considerations and other cost sensitive aspects of the proposed activity.
- d) A maximum of ten percent (10%) of approved work expenditures may be attributed to overhead expenses for work carried out on the exploration permit.
- e) An affidavit shall be required from the permittee attesting to the actual expenditures incurred for work completed, on the exploration permit, in fulfillment of work obligations. The affidavit may also need to be supported by documental evidence of expenditures.
- f) A permittee may fulfill work obligations related to an exploration permit by carrying out exploration surveys, the drilling of wells or any other activities approved on the exploration permit.

6. Terms and Conditions

- a) Subject to subsection 24(2) of the *Petroleum Regulations*, an exploration permit issued pursuant to this request for bids shall be subject to the following:
 - i) a permittee agrees that certain petroleum operations may be restricted due to land-use constraints;
 - ii) before commencing any work relating to the exploration for or exploitation of petroleum within the exploration permit, a permittee shall obtain all necessary approvals and authorizations from government departments, agencies, municipalities and other rights holders respecting access to and use of lands within the exploration permit;
 - iii) the sections of land to which an exploration permit applies does not include any areas within a park, reserve, or fee-simple mining grant, and only includes areas within the application of the *Petroleum Regulations*; and
 - iv) the permittee may relinquish any portion of the exploration permit with the approval of the Director, however, such a relinquishment shall not change the work obligation on the exploration permit.
 - v) Parcels 1, 2, 5, 9 and 10 contain Protected Water Supply areas, and will therefore be subject to certain restrictions, buffer zones, and approvals.

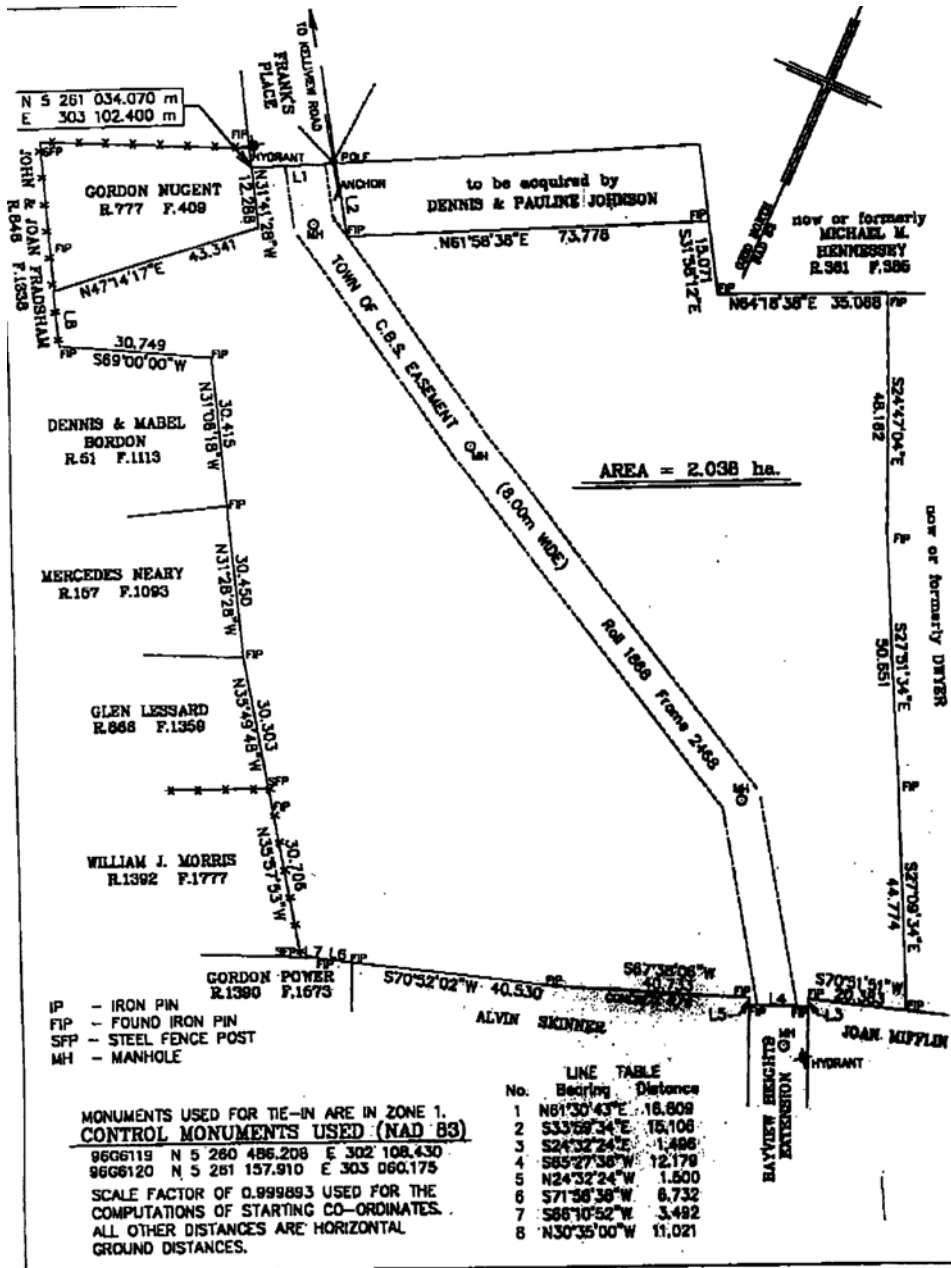

1. Section 45 of the *Local Service District Regulations* is repealed and the following substituted:

Entry permitted

45. (1) A committee or its authorized representative may, upon giving reasonable notice and at a reasonable time, enter upon all property within the local service district and into buildings and structures on that property, whether publicly or privately owned, to do all things necessary for the purpose of making surveys or examinations or obtaining information relative to the construction, attention, repair, maintenance or inspection of a public water supply system that the committee is empowered to undertake or control.

(2) Notwithstanding subsection (1), a committee or its authorized representative may enter upon property without notice where an emergency exists relevant to the operation of the water supply system but in so doing it shall make every reasonable effort to address the emergency without inconvenience to the owner or occupier of that property.

(3) Notwithstanding subsections (1) and (2), a committee or its authorized representative shall not enter upon, break up or otherwise interfere with a highway vested in the Crown under section 5 of the *Works, Services and Transportation Act* without the written consent of the minister responsible for that Act under the *Executive Council Act*.

2. Section 48 of the regulations is repealed and the following substituted:

Entry permitted

48. (1) A committee or its authorized representative may, upon giving reasonable notice and at a reasonable time, enter upon all property within the local service district and into buildings and structures on that property, whether publicly or privately owned, to do all things necessary for the purpose of making surveys or examination or obtaining information relative to the construction, attention, repair, maintenance or inspection of a public sewage system that the committee is empowered to undertake or control.

(2) Notwithstanding subsection (1), a committee or its authorized representative may enter upon a property without notice where an emergency exists relevant to the operation of the sewage system but in so doing, shall make every reasonable effort to address the emergency without inconvenience to the owner or occupier of the property.

(3) Notwithstanding subsections (1) and (2), a committee or its authorized representative shall not enter upon, break up or otherwise interfere with a highway vested in the Crown under section 5 of the *Works, Services and Transportation Act* without the written consent of the minister responsible for that Act under the *Executive Council Act*.
