1. These regulations may be cited as the *Petroleum Products Assessment Regulations*, 2003.

Annual assessment fee

2. (1) A wholesaler or retailer who refines or brings petroleum products into the province, or receives delivery of petroleum products in the province from a retailer or wholesaler outside the province who does not carry on business in the province, shall pay quarterly to the

commissioner an assessment fee on designated petroleum products at the rate of \$0.0007 a litre.

(2) The fee imposed under subsection (1) applies whether or not the designated petroleum product is subject to price regulation under the Act.

(3) The quarterly assessment fee shall be based upon the annual volume, divided by 4, of designated petroleum products sold by the wholesaler or retailer in the calendar year previous to the calendar year in which the assessment fee is due to the commissioner.

(4) Payments of the quarterly assessment fee imposed under subsection (1) shall be made in the time and manner that the commissioner may require.

(5) In this section,

- (a) "designated petroleum products" means petroleum products other than marine fuel, aviation fuel, and marked diesel; and
- (b) "marked diesel" means tax exempt diesel marked in accordance with the *Gasoline Tax Act*.

3. The *Petroleum Products Assessment Regulations*, Newfoundland and Labrador Regulation 92/01, are repealed.

6. (1) Rule 10 of Schedule D of the regulations is repealed and the following substituted:

10. Discounted prices shall not be allowed for ticket sales, unless there is a method that ensures financial accountability that has been approved by the division.

(2) Rules 17 and 18 of Schedule D of the regulations is repealed and the following substituted:

17. The licensee may accept cheques or credit payments, and shall be responsible for ensuring that the proceeds from ticket sales are validated before the prize is awarded. If the proceeds cannot be verified for a winning ticket a subsequent draw shall take place to award the prize.

18. (1) A licensee may operate an early bird draw.

(2) An early bird draw shall not be held unless approved by the division and a minimum of 14 days is allotted to account for tickets before the draw takes place.

(3) A shorter period than that provided in subrule (2) may be approved by the division where requested in writing setting out the method that will be used to ensure accountability.

(4) The cut-off date for an early bird draw shall be printed on the ticket.

(3) Rule 22 of Schedule D of the regulations is repealed and the following substituted:

22. Where the winner is under 19 years of age, the licensee shall deliver the prize to his or her legal guardian.

7. Rule 15 of Schedule F of the regulations is amended by renumbering it as subrule (1) and adding immediately after it the following:

(2) A licensee shall ensure that monte carlo wheels of fortune, tables and games are conducted by representatives of the licensee, and includes dealers for blackjack and poker tables.

(3) A representative shall not wager a bet while conducting a wheel of fortune, table or game.

8. (1) Rule 2 of Schedule G of the regulations is repealed and the following substituted:

2. Discounted prices shall not be allowed for ticket sales, unless there is a method that ensures financial accountability that has been approved by the division.

(2) Rule 19 of Schedule G of the regulations is repealed and the following substituted:

19. A spreadsheet, as approved by the division, or a copy of all entries shall be received by the division, or postmarked, not later than 4:00 p.m. of the day that is 24 hours before the commencement of the games. Failure to comply with this, may result in the licence being revoked and participants' monies being refunded.
