



### NEWFOUNDLAND AND LABRADOR REGULATION 45/03

Home Heating Fuel Tax Credit Regulations (Amendment) under the
Income Tax Act, 2000
(O.C. 2003-165)

(Filed April 9, 2003)

Under the authority of section 68 of the *Income Tax Act, 2000*, the Lieutenant-Governor in Council makes the following regulations.
