**CANADA-NEWFOUNDLAND AND LABRADOR ATLANTIC ACCORD IMPLEMENTATION

**CANADA-NEWFOUNDLAND OFFSHORE PETROLEUM BOARD
CALL FOR BIDS No. NF03-1**

The Canada-Newfoundland Offshore Petroleum Board hereby gives notice of a call for the submission of bids in respect of fourteen parcels in the Newfoundland offshore area.

This notice of the Call for Bids No. NF03-1 is made pursuant and subject to the *Canada-Newfoundland Atlantic Accord Implementation Act*, S.C., 1987, c. 3, and the *Canada-Newfoundland and Labrador Atlantic Accord Implementation Newfoundland and Labrador Act*, R.S.N. 1990, c. C-2.

The following is a summary of the Call for Bids No. NF03-1:

- (i) Sealed bids will be received by the Board prior to the time of closing of this call for bids. This call for bids will close at 4:00 p.m., Newfoundland Standard Time, on December 17, 2003;

- (ii) All bids must be submitted in accordance with the terms and conditions of the Call for Bids No. NF03-1;
- (iii) The fourteen parcels are located offshore Newfoundland and Labrador and are described in Schedule I. Exploration Licences may be issued for each parcel.
- (iv) For the purpose of selecting a bid, the sole criterion to be used will be the total amount of money the bidder commits to expend on exploration on the respective parcel within Period I ("Work Expenditure Bid");
- (v) A minimum Work Expenditure Bid of \$ 1 million will be required for each parcel.
- (vi) For each parcel, the Work Expenditure Bid must be accompanied by a *bank draft or certified cheque* in the amount of \$10,000 ("Bid Deposit") made payable to the Receiver General. Furthermore, the successful bidder will be required to provide, within 15 days of notification of being the successful bidder, a promissory note in the amount of 25% of the Work Expenditure Bid ("Security Deposit"). A credit against the Security Deposit will be made on the basis of 25% of allowable expenditures as described in Schedule III of the Exploration Licence ("Allowable Expenditures");
- (vii) Each successful bidder will receive a refund, without interest, of the Bid Deposit when the Security Deposit is posted within 15 days. Failure to post the Security Deposit within 15 days will result in forfeiture of the Bid Deposit and disqualification of the bid.

Upon the announcement of the bid results, the Bid Deposits of unsuccessful bidders will be returned, without interest, as soon as possible;
- (viii) For each parcel, an Exploration Licence will be issued for a term of nine years consisting of two consecutive periods of five years (Period I) and four years (Period II). Period I may be extended to six years by posting an additional deposit of one million dollars as security for drilling a well; Period II will comprise the balance of the nine-year term.
- (ix) For each parcel, the licence requirement will be one well to be commenced within Period I and diligently pursued thereafter.
- (x) For each parcel, rentals will be applicable only in Period II at the following rates:
 - 1st year- \$2.50 per hectare
 - 2nd year- \$5.00 per hectare
 - 3rd year- \$7.50 per hectare
 - 4th year- \$7.50 per hectare

When an Exploration Licence continues in force beyond Period II, rentals will be payable at the rates applicable during the last year of Period II.

Rentals will be payable annually, in advance, and are to be submitted by cheque payable to the Receiver General, except for rentals applicable to an Exploration Licence continuing beyond Period II, which will be payable monthly, in advance, at the rate of one-twelfth (1/12) of the applicable annual rates.

Rentals will be refunded annually, to a maximum of 100% of the rentals paid in that year, on the basis of a dollar refund for each dollar of Allowable Expenditures for that year.

Carry forward provisions to reduce rentals otherwise payable in ensuing rental years will apply.

Rentals will apply to lands subject to a declaration of significant discovery during the term of the Exploration Licence at the rates and levels of refundability specified above;

- (xi) An Allowable Expenditure schedule will have application throughout Period I of the Exploration Licence. The rates of Allowable Expenditures will be reviewed, and may be amended, at the expiration of Period I;

- (xii) A successful bidder will be required to comply with the Canada-Newfoundland Benefits procurement, employment and reporting procedures as established by the Board;
- (xiii) The parcels will be subject to the payment of issuance fees and Environmental Studies Research Fund levies;
- (xiv) The Board is not obliged to accept any bid or issue any interest as a result of this call for bids;
- (xv) Any licence that may be issued shall be in the form of the Exploration Licence attached to the Call for Bids NF03-1;

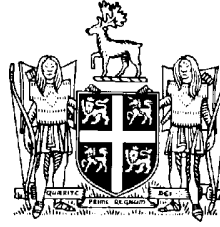

1. Section 2 of the *Fish Inspection Regulations* is amended by adding immediately after paragraph (g) the following:

(g.01) "grading" means the process of measuring fish based on the characteristics of

(i) texture,

- (ii) life condition,
- (iii) size,
- (iv) color,
- (v) odour,
- (vi) leg loss, and
- (vii) the absence or presence of other defects

to identify the means by which fish will be marketed.

2. The regulations are amended by adding immediately after section 34 the following :

Licence suspension

34.1 (1) Where the holder of a fish processing licence or a fish buyers licence is determined by the minister to be in breach of a condition of his or her licence with respect to grading, the minister may suspend that licence

- (a) for a first breach, for a minimum period of 24 hours;
- (b) for a second breach, for a minimum period of 7 days; and
- (c) for a third or subsequent breach, for a minimum period of 30 days.

(2) The minister may require

- (a) that, in addition to any conditions imposed by the minister under section 32 or 34, the licence holder take those steps or comply with those conditions that the minister may impose; and
- (b) that the licence holder provide proof of compliance with the conditions referred to in paragraph (a), including written proof where required.

(3) Proof of compliance referred to in subsection (2) includes, but is not limited to

(a) a certified copy of a contract of grading; and

(b) verification by an inspector that the licence holder is complying with any imposed conditions.

(4) A suspension imposed under subsection (1) shall remain in place until the licence holder, to the satisfaction of the minister

(a) complies with any conditions of licence and other conditions that may be imposed under this section; and

(b) submits the proof of that compliance that the minister may require.

(5) Where the minister is satisfied that the licence holder has complied with the conditions of his or her licence and those conditions that may be imposed under this section, the minister may revoke the suspension of that licence.

(6) Nothing in this section affects the ability of the minister to cancel a licence under section 37.

Minister to give
notice

34.2 The minister shall provide the holder of the fish processing licence or the fish buyers licence whose licence is suspended with a notice including

(a) the time from which the licence suspension takes effect;

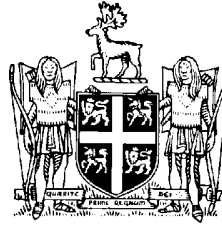
(b) the period during which his or her licence may be suspended; and

(c) the conditions with which he or she shall comply in order to have the suspension revoked.

Commencement

3. These regulations shall come into force on May 1, 2003.

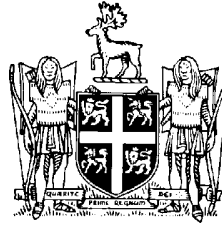

Short title

1. This Order may be cited as the *Voisey's Bay Special Project Order*.

Special project declared	2. It is declared that the undertaking with respect to the construction of an open pit mine and concentrator that will occur at Voisey's Bay, Labrador, is a special project.
Parties who may bargain collectively	3. The parties that may be involved in collective bargaining in relation to employment on the special project are Voisey's Bay Employers Association Inc., as the employers' organization (the "employer") acting for and on behalf of all contractors and subcontractors carrying out work on the special project, and the Resource Development Trades Council of Newfoundland and Labrador, as the council of trade unions (the "union"), acting for and on behalf of all affiliated unions which represent employees employed on the special project.
Collective agreement	4. The collective agreement entered into between the Voisey's Bay Employers Association Inc. and the Resource Development Trades Council of Newfoundland and Labrador effective September 9, 2002 (the "agreement"), is the collective agreement for the purpose of the special project.
Single bargaining unit	5. For the purposes of the special project, all employees employed on the special project under the agreement are considered to be members of a single bargaining unit.
Undertaking Order and Impacts and Benefits Agreements	6. This Order acknowledges that the adjacency principle as referenced in the Voisey's Bay Nickel Company Limited Mine and Mill Undertaking Order ("undertaking order") and the commitments respecting employment made by Voisey's Bay Nickel Company Limited ("VBNC") in the Innu and LIA Impacts and Benefits Agreements, respectively, have application to the project.
Women's employment plan	7. This Order acknowledges the commitment contained in the undertaking order with respect to the development of a women's employment plan for the project.
How long Order remains in effect	8. This Order remains in effect until construction, including mobilization and demobilization, and pre-operational work, as defined in the agreement, for the project have been completed and the Voisey's Bay Nickel Company Limited has issued the appropriate certificates of completion to the contractors as defined in the agreement.

Service of application on respondent

6. (1) An application or notice to be served on a respondent by the designated authority under subsection 10(1) or 30(1) of the Act shall be served

(a) personally; or

(b) by registered mail.

(2) A notice served on the respondent by the designated authority under paragraph 10(1)(b) or 30(1)(b) of the Act shall require the respondent to file a response with the court, together with a financial statement, in the form required by the designated authority.

(3) There shall be at least 30 days between

(a) the date of service of the application and notice; and

(b) the date set out in the notice for hearing the application.

Providing copies of order

7. For the purpose of subsection 7(4) or 26(4) of the Act, the designated authority who receives an order from a reciprocating jurisdiction shall send a copy of the order and reasons, if any, to the claimant or applicant by ordinary mail at the address specified on the support application or the most current address provided by the claimant or applicant.

Where provisional order required

8. (1) Where a reciprocating jurisdiction requires a provisional order referred to in section 8 of the Act, the claimant shall

(a) apply for the order by completing the support application referred to in subsection 6(2) of the Act, which

(i) is in the form required by the designated authority, and

(ii) includes the documents referred to in subsection 4(1) of these regulations; and

(b) submit the support application and a proposed provisional order to the court.

(2) The support application, including the documents referred to in subparagraph (1)(a)(ii), is evidence in the proceeding.

(3) Unless otherwise directed by the court, an application for a provisional order may proceed without an appearance by the claimant.

Copy of order

9. (1) The designated authority shall send a certified copy of an order to the appropriate authority under section 16 or 35 of the Act by

(a) facsimile transmission; or

(b) ordinary mail.

(2) Where the court makes an order in the absence of the respondent under subsection 15(4) or 34(4) of the Act, the court shall send a copy of the order to the respondent by ordinary mail at the respondent's last known address as noted on the court file.

Foreign orders

10. (1) For the purpose of subsection 20(1) of the Act, the designated authority shall deliver notification of the registration of a foreign order

(a) personally; or

(b) by registered mail.

(2) Where a party to a foreign order wishes to apply under subsection 20(2) of the Act to set aside the registration of the foreign order, within 30 days after receiving notification of the registration of the foreign order, the party shall

(a) serve notice of the application on the designated authority

(i) personally,

(ii) by facsimile transmission, or

(iii) by registered mail; and

(b) file the application, with proof of service on the designated authority, in the court at the judicial centre nearest to the party's residence.

(3) Unless the designated authority consents to an earlier date for hearing the application mentioned in subsection (2), there shall be at least 30 days between

- (a) the date of service of the application; and
- (b) the date set for hearing the application.

(4) For the purpose of subsection 20(6) of the Act, the party who applies to set aside the registration of a foreign order shall give notice of the decision or order of the court to the other party and to the designated authority

- (a) by facsimile transmission; or
- (b) by ordinary mail.

Where provisional
order of variation
required

11. (1) Where a reciprocating jurisdiction requires a provisional order of variation referred to in section 28 of the Act, the applicant shall

- (a) apply for the order by completing the support variation application referred to in subsection 25(2) of the Act, which
 - (i) is in the form required by the designated authority, and
 - (ii) includes the documents referred to in subsection 4(2) of these regulations; and
- (b) submit the support variation application and a proposed provisional variation order to the court.

(2) The support variation application, including the documents referred to in subparagraph (1)(a)(ii), is evidence in the proceeding.

(3) Unless otherwise directed by the court, an application for a provisional order of variation may proceed without an appearance by the applicant.

Foreign currency

12. (1) For the purpose of section 42 of the Act, where a foreign order refers to an amount of support that is not expressed in Canadian currency, the designated authority shall convert the amount into Canadian currency using the rate of exchange applicable on the day the foreign order was made or last varied.

(2) For the purpose of converting the amount mentioned in subsection (1) into Canadian currency, the designated authority may obtain the applicable rate of exchange from a bank.

(3) Where the designated authority files with the court a statement setting out the amount mentioned in subsection (1) in Canadian currency, the amount in that statement is considered to be the amount of the foreign order.
