The corresponding Development Regulation Amendment No. 5 will rezone the area from Residential Medium Density to Mixed Development. The purpose of the Development Regulation No. 6 is to clarify conditions with respect to development near water bodies, restricting development within 15 m of a body of water unless approved by applicable federal and provincial agencies.

The Conception Bay South and Municipal Plan Amendment No. 3, 2003 and Development Regulations Amendments No. 5 and 6, 2003 will come into effect on the 15<sup>th</sup> day of August 2003, the date of publication in *The Newfoundland and Labrador Gazette*. 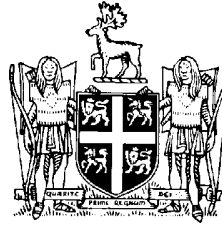

## **NEWFOUNDLAND AND LABRADOR REGULATION 93/03**

*Victoria Municipal Planning Area, 2003*  
under the  
*Urban and Rural Planning Act, 2000*

*(Filed August 7, 2003)*

Under the authority of section 11 of the *Urban and Rural Planning Act, 2000*, I define the following area as the Victoria Municipal Planning Area.

### **PLANNING AREA**

Beginning at the northwestern side of Gull Pond;

Then south 84° 34' 22" east 10,000 metres, more or less, to a hill,  
known elevation of 176.4 metres;

Then north 63° 35' 17" east, 4,854 metres, more or less;

Then running north 541 metres, more or less, to the most eastern point  
of Forest Pond;



Then in a generally westerly direction along the northern shoreline of Forest Pond to the south corner of the eastern boundary of the land of the Persalvic Regional High School;

Then northward along that boundary to the main highroad of Salmon Cove;

Then northward 6,750 metres, more or less, to a hill, known elevation of 308 metres;

Then north  $87^{\circ}$  west 7,166 metres;

Then in a generally southerly direction to the southeastern abutment of a Halfway Bridge;

Then south  $80^{\circ} 27' 21''$  west, 1,707 metres, more or less, to a point;

Then south  $31^{\circ} 19' 09''$  west, 7,850 metres, more or less, to the north-western side of Gull Pond, the point of beginning.

All bearings refer to Grid North and, as with distances given, are subject to approximation as delineated on the 1:2,500 and 1:50,000 Topographic Mapping.

The *Victoria Municipal Planning Area*, Consolidated Newfoundland and Labrador Regulation 945/96 is repealed.
