#### REPORT OF THE CHIEF ELECTORAL OFFICER ON ELECTION FINANCES FOR THE BY ELECTION HELD IN THE ELECTORAL DISTRICT OF BONAVISTA NORTH JULY 24th, 2002

#### PUBLISHED UNDER THE AUTHORITY OF SECTION 273, ELECTIONS ACT, 1991, CHAPTER E-3.1

#### **ELECTION FINANCE REPORT**

Part III - Election Finances, of the Elections Act, 1991 was proclaimed into force on October 1, 1993. In addition to outlining the powers and duties of the Chief Electoral Officer with respect to Election Financing, the Act establishes a regulatory framework for campaign financing and the reporting of financial information applicable to elections and by-elections in this Province.

#### **CAMPAIGN FILINGS**

Section 304 of The Elections Act requires candidates in a by-election and political parties that received contributions or made expenditures in relation to the by-election to file with the Chief Electoral Officer a financial statement of income and expenses relating to the by-election within six months of polling day.

There were four filings relating to the Bonavista North by-election. Each of the three candidates who contested the by-election were required to file audited financial statements. The Liberal Party, which received contributions and reported direct expenditures relating to the by-election, was also required to file. The Progressive Conservative and New Democratic Parties did not report contributions or direct election related expenditures and therefore did not file audited financial statements.

Two of the four filed reports were received by the Chief Electoral Officer after the January 24th, 2003 deadline specified under the legislation. The filing for the Beaton Tulk campaign was received on February 14th, 2003 and the John Whelan campaign filing was received March 27th, 2003.

Subsection 324(1) of the Elections Act provides that a chief financial officer who either willfully of through neglect fails to file a financial return with the Chief Electoral Officer within the time specified by legislation, commits an offence and is liable on summary conviction to a fine of \$50.00 per day for each day he or she is in default of filing the return.

In each of the above noted cases, the Chief Electoral Officer reviewed the circumstances and explanations for the late filings and determined that willful intent or neglect on the part of the chief financial officers were not contributing factors to the filing delays. The decision was made not to pursue further action on this matter.

# EXPENDITURE LIMITS

Section 310 of the Elections Act, 1991 places a limitation on the amount of certain election expenses permitted by political parties and candidates in an election.

These limits are established for each district based on the number of eligible voters on the official voter's list to be used for an election multiplied by an inflation adjusted factor of \$3.433 (for 2002) per voter.

Based on these numbers, the allowable limit for the Bonavista North by-election was set by the Chief Electoral Officer at \$26,616.00 on the date the writ for the election was issued.

As previously mentioned, election expenditure limits apply only to certain expenditures made by a campaign. The limits are not applicable to candidates and their spouses travel and personal living expenses, to amounts spent on wrap-up or election night thank you parties, to amounts transferred to candidates or parties or to other expenses not directly related to contesting of the election.

The reason or logic for excluding such expenses is rooted in the principle of fairness and in attempts to create as level a playing field as possible for all candidates. For instance, a candidate who maintains a permanent residence in a particular district would likely incur less travel and living expenses than a candidate who does not and would obtain a spending advantage if that other candidate faced limits on living expenses.

Factoring in adjustments for these types of expenses the Harry Harding Campaign exceeded the allowable expenditure limit for the district by \$220.00. (see appendix A- Financial Report Summary).

Section 320 of the Elections Act provides that a person who knowingly incurs or authorizes election expenses which exceed the maximum allowable expense limit established by the Chief Electoral Officer is liable on summary conviction to a fine not exceeding \$10,000, to imprisonment for a term not exceeding 3 months or to both a fine and imprisonment.

With respect to the overage incurred by the Harry Harding campaign, the Chief Electoral Office looked closely at the circumstances leading to and/or giving rise to it.

Firstly, there was some confusion on the part of the chief financial officer for the campaign as to whether certain expenses incurred after polling day, (bank charges and interest expenses relating to a campaign loan), should in fact count towards calculating limits. Under electoral legislation in other jurisdictions in Canada such expenses are not universally considered for the purpose of calculating expenditure limits.

Secondly, in this particular campaign the political parties used different methods to report certain campaign expenditures. The Liberal Party chose to spend money directly on the campaign by directly paying and reporting travel expenses to the district for some party workers while the PC party chose instead to transfer money to it's candidate's campaign some of which was then used to pay similar travel expenses for PC party workers. Both approaches are entirely acceptable under legislation but would result in the PC candidate's campaign reporting a higher expenditure on travel then if the party had chosen to pay those expenses itself.

The Chief Electoral Office is satisfied that negligence or willful intent were not factors contributing to the overrun and given the relative size of the excess and the reporting options available to the parties concerned, further action was not felt to be necessary.

Other than the above noted exceptions the filings for the Bonavista North by-election contained relatively few and minor compliance issues and all have been resolved to the satisfaction of the Chief Electoral Officer.

#### EXPENSE SUBSIDIES

Two of the three candidates in the by-election received at least fifteen percent of the popular vote cast in their districts. As a result their campaigns were entitled to receive an election expense reimbursement calculated to be 1/3 of their eligible allowable campaign expenses up to a maximum of 1/3 of their district's expenditure limit. Subsidy amounts paid were as follows:

Harry Harding	(PC candidate)	\$8,872
Beaton Tulk	(Liberal candidate)	\$8,819

Section 313 of the Elections Act requires that campaign surpluses created either from political contributions, expense subsidies or other sources permitted under the Act, be remitted to the appropriate party if a candidates political affiliation appears on the ballot.

For the Bonavista North by-election the amounts calculated as transferred/payable to the political parties under this provision of the legislation are as follows:

Liberal Party	\$1,106
Progressive Conservative Party	(nil)
New Democratic Party	128

In addition to the campaign expense subsidy payable to candidates the Chief Electoral Officer also subsidizes the cost of auditor services to candidates to a maximum amount of \$500 per campaign paid directly to a candidate's auditors. The total auditor subsidy amount paid for the by-election was \$1,500.00.

# **CONTRIBUTIONS**

Subsection 299(4) of the Elections Act, 1991 requires that a registered party and a candidate in an election shall, along with the statements of income and expenses for the election required under Section 304, file a listing with respect to contributions received in a campaign period that either individually or in sum exceed \$100 together with the name and address of the contributor(s).

Information respecting contributions is contained in the table(s) attached to this report.

# **OTHER ISSUES**

Prior to the date the writ was issued for the Bonavista North by-election, the Chief Electoral Office received several anonymous complaints from district residents concerning public advertising which was/had been occurring relating to the political party nomination process for official party candidates.

The Chief Electoral Officer feels that it is important for members of the general public, including potential future candidates in elections to understand that current Election Finance legislation does not apply to campaigns or conventions carried on or held in relation to the leadership of a registered party or in relation to district nominations for endorsement of official party candidates.

In relation to these events, the various political parties have their own charters and rules and regulations which govern the conduct of their potential candidates. Individuals with complaints respecting these processes are normally referred to the various political party executive or complaint mechanisms.

However, the Elections Act does specify that certain costs incurred by prospective candidates in these district nomination bids "may" be considered election expenses in the event the successful nominee does in fact run in the next general or by-election called for their district. In this regard, all prospective candidates are advised by the Chief Electoral Office to maintain a proper accounting record of nomination related income and expenses since the Elections Act requires reporting of these items should the candidate eventually seek public office.

In addition to complaints about the party nomination process, and subsequent to the actual by-election, the Chief Electoral Office received two complaints, one from a private individual and another from the Liberal Party concerning the use of a motorhome by the PC Party leader during the by-election campaign period.

Circumstances relating to this complaint have been investigated by The Chief Electoral Officer and a report on his investigation has been issued to each of the provincially registered political parties. With respect to the private individual's complaint, the Chief Electoral Officer was unable to directly contact the individual because the complainant failed to provide a return address or phone number and efforts to otherwise identify the complainant failed.

### REPORT OF THE CHIEF ELECTORAL OFFICER ON ELECTION FINANCES FOR THE BY ELECTION HELD IN THE ELECTORAL DISTRICT OF CONCEPTION BAY SOUTH

NOVEMBER 12th, 2002

# PUBLISHED UNDER THE AUTHORITY OF SECTION 273, ELECTIONS ACT, 1991, CHAPTER E-3.1

### **ELECTION FINANCE REPORT**

Part III - Election Finances, of the Elections Act, 1991 was proclaimed into force on October 1, 1993. In addition to outlining the powers and duties of the Chief Electoral Officer with respect to Election Financing, the Act establishes a regulatory framework for campaign financing and the reporting of financial information applicable to elections and by-elections in this Province.

# CAMPAIGN FILINGS

Section 304 of The Elections Act requires candidates in a by-election and political parties that received contributions or made expenditures in relation to the by-election to file with the Chief Electoral Officer a financial statement of income and expenses relating to the by-election within six months of polling day.

There were four filings relating to the Conception Bay South by-election. Each of the three candidates who contested the by-election was required to file audited financial statements. The Liberal Party, which reported direct expenditures relating to the by-election, was also required to file. The Progressive Conservative and New Democratic Parties did not report contributions or direct election related expenditures and therefore did not file audited financial statements.

All of the reports were received by the Chief Electoral Officer by the filing deadline of May 12th, 2003 specified under the legislation.

# **EXPENDITURE LIMITS**

Section 310 of the Elections Act, 1991 places a limitation on the amount of certain election expenses permitted by political parties and candidates in an election.

These limits are established for each district based on the number of eligible voters on the official voter's list to be used for an election multiplied by an inflation adjusted factor of \$3.433 (for 2002) per voter.

Based on these numbers, the allowable limit for the Conception Bay South by-election was set by the Chief Electoral Officer at \$28,113.00 on the date the writ for the election was issued.

As previously mentioned, election expenditure limits apply only to certain expenditures made by a campaign. The limits are not applicable to candidates and their spouses travel and personal living expenses, to amounts spent on wrap-up or election night thank you parties, to amounts transferred to candidates or parties or to other expenses not directly related to contesting of the election.

The reason or logic for excluding such expenses is rooted in the principle of fairness and in attempts to create as level a playing field as possible for all candidates. For instance, a candidate who maintains a permanent residence in a particular district would likely incur less travel and living expenses than a candidate who does not and would obtain a spending advantage if that other candidate faced limits on living expenses.

Factoring in adjustments for these types of expenses each of the three candidates and the Liberal Party were within the allowable district expenditure limit. (See appendix A- Financial Report Summary).

## EXPENSE SUBSIDIES

Two of the three candidates in the by-election received at least fifteen percent of the popular vote cast in the district. As a result their campaigns were entitled to receive an election expense reimbursement calculated to be 1/3 of their eligible allowable campaign expenses up to a maximum of 1/3 of their district's expenditure limit. Subsidy amounts paid were as follows:

Terry French	(PC candidate)	\$8,224
Gary Corbett	(Liberal candidate)	\$9,071

Section 313 of the Elections Act requires that a campaign surplus created either from political contributions, expense subsidies or other sources permitted under the Act, be remitted to the appropriate party if a candidate's political affiliation appears on the ballot.

For the Conception Bay South by-election the amounts calculated as transferred/payable to the political parties under this provision of the legislation are as follows:

Liberal Party	\$9,211
Progressive Conservative Party	\$ 349
New Democratic Party	\$1,150

In addition to the campaign expense subsidy payable to candidates the Chief Electoral Officer also subsidizes the cost of auditor services to candidates to a maximum amount of \$500 per campaign paid directly to a candidate's auditors. The total auditor subsidy amount paid for the by-election was \$1,500.00.

# **CONTRIBUTIONS**

Subsection 299(4) of the Elections Act, 1991 requires that a registered party and a candidate in an election shall, along with the statements of income and expenses for the election required under Section 304, file a listing with respect to contributions received in a campaign period that either individually or in sum exceed \$100 together with the name and address of the contributor(s).

Information respecting contributions is contained in the table attached as Appendix B of this report.

# **COMMENTS**

Of chief concern with respect to compliance with election finance legislation is the receipt, recording and reporting of political contributions and responsibility for the expenditure and disbursement of such funds and any other funds such as subsidies or transfers collected under other provisions of the Act. This office and the legislated reporting system is dependent on the integrity of the many people involved in the political process, candidates, their financial managers and campaign workers and the licensed Public Auditors who perform the required audits and report the results to the Chief Electoral Officer.

With respect to legislative compliance, the Conception Bay South by-election was perhaps one of the easiest elections this office has had to administer. There were relatively few and minor compliance issues to deal with and all have been resolved to the satisfaction of the Chief Electoral Officer.

### **PUBLIC DOCUMENTS**

The tables that follow present a summary of the financial information filed under Sections 299 and 304 relating to the Conception Bay South by-election of November 12, 2002. The actual financial statements on which the summaries are based are public documents and may be viewed at the Office of the Chief Electoral Officer during normal business hours.
