TOWN OF GANDER MUNICIPAL PLAN
AMENDMENT NO. 2, 2003
AND DEVELOPMENT REGULATIONS
AMENDMENT NO. 4, 2003

Take notice that the Town of Gander Municipal Plan Amendment No. 2, 2003 and Development Regulations

Amendment No. 4, 2003, adopted on the 23rd day of July, 2003, and approved on the 3rd day of September, 2003, has been registered by the Minister of Municipal and Provincial Affairs.

In general terms, the purpose of Municipal Plan Amendment No. 2, 2003 is to re-designate a 8.50 ha parcel of land on the Trans Canada Highway to a Commercial Highway Land Use designation.

The purpose of Development Regulations Amendment No. 4, 2003 is to re-zone the same parcel of land to Commercial Highway, remove "Service Station" from the Permitted Use Classes of the Commercial Highway zone and add "Apartment Building, Collective Residential and Service Station" to the Discretionary Use Classes of this zone.

The Gander Municipal Plan Amendment No. 2, 2003 and Development Regulations Amendment No. 4, 2003 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of these amendments may do so at the Town Office, Gander during normal working hours. (8:30am to 4:30 pm)
