In general terms, the purpose of St. John's Municipal Plan Amendment Number 3, 2003 is to redesignate property located between Quidi Vidi Village Road and Cuckhold's Cove Road, to the Residential Low Density Land Use District.

In general terms, the purpose of St. John's Development Regulations Amendment Number 296, 2003 is to rezone land located between Quidi Vidi Village Road and Cuckhold's Cove Road, to the Residential Medium Density (R2) Zone.

In general terms, the purpose of St. John's Development Regulations Amendment Number 300, 2003, is to rezone land located at Empire Avenue and Jensen Camp road to the Residential Medium Density (R2) Zone.

In general terms, the purpose of St. John's Development Regulations Amendment Number 301, 2003, is to rezone land located at Logy Bay Road, between Cook's Lane and the Outer Ring Road, to the Residential Low Density (R1) Zone.

In general terms, the purpose of St. John's Development Regulations Amendment Number 302, 2003, is to rezone land located at Logy Bay Road, between Cook's Lane and the Outer Ring Road, to the Commercial Neighbourhood (CN) Zone.
