The dates of these Board Meetings were April 23-24, 2003; June 2-3, 2003; November 6-7, 2003 and January 29-30, 2004. These recommendations affect the following National Topographic Series (NTS) mapsheets: St. Catherine's (1N/3); Holyrood (1N/6); Pouch Cove (1N15); Gambo (2D/16); Comfort Cove-Newstead (2E/7); Fogo (2E/9) Little Fogo Islands (2E/16); Soufflets River (12I/7); Great Harbour Deep (12I/8); Englee (12I/9); Torrent River (12I/10); Castors River (12I/15) and Roddickton (12I/16).

These names were compiled by several independent and voluntary field surveys which involved consultation with members of the general public. The efforts of the data collectors and informants are gratefully acknowledged.
