In general terms, the purpose of Municipal Plan Amendment No. 1, 2003, is (a) to allow orderly serviced residential development from the rears of properties fronting on Highway 70 – the Conception Bay North Highway – to the Old Track – both sides of it, down to Beaver Pond and the stream that feeds into and (b) allow serviced residential development off Powell's Road.

In general terms, the purpose of Development Regulations Amendment No. 1, 2003, is to implement the Municipal Plan Amendment.



Local Service District of Caplin Cove-Southport under the Municipalities Act, 1999

Local service district established

1. The area comprising the communities of Southport, Gooseberry Cove, Butter Cove, Little Heart's Ease and Caplin Cove in the Electoral District of Trinity North is established as a local service district by the name of the Local Service District of Caplin Cove-Southport.

Boundaries

2. The boundaries of the local service district shall be the area comprising the communities referred to in section 1.

Committee

3. A local service district committee shall be elected to control and manage the affairs of the local service district according to the *Municipalities Act*, 1999 and the *Local Service District Regulations*.

Wild Life Regulations (Amendment) under the Wild Life Act (O.C. 2004- 308)

(Filed August 23, 2004)

Under the authority of section 7 of the *Wild Life Act*, the minister, with the approval of the Lieutenant-Governor in Council, makes the following regulations.

1. S.2 Amdt. Definitions

2. S.8.1 Added Disabled angler CNLR 1156/96 as amended

- 1. (1) Paragraph 2(d.2) of the *Wild Life Regulations* is amended by striking out the word "resident" and substituting the word "person".
- (2) Paragraph 2(d.3) of the regulations is amended by striking out the words "resident of the province" and substituting the word "person".
- (3) Section 2 of the regulations is amended by adding immediately after paragraph (d.1) the following:
 - (d.02) "designated angler" means a person who holds an inland fishery licence, river specific inland fishery licence or a family inland fishery licence and is designated by a disabled angler to angle and retain a species of fish that the disabled angler is permitted by law to catch and retain;
- (4) Section 2 of the regulations is amended by adding immediately after paragraph (d.2) the following:
 - (d.03) "disabled angler" means a person who is
 - (i) permanently legally blind, or
 - (ii) permanently mobility impaired, and

who holds an inland fishery licence, river specific inland fishery licence or a family inland fishery licence;

2. The regulations are amended by adding immediately after section 8 the following:

Disabled angler

- **8.1** (1) A disabled angler may specify one designated angler to angle and retain the species set out in the disabled angler's licence, in the area permitted and within the bag limits set by law.
 - (2) A designated angler shall
 - (a) keep within 100 metres of the disabled angler, except when in pursuit of a fish that has been hooked for the disabled angler;

- (b) possess the licence and tags of the disabled angler while angling for that disabled angler; and
- (c) immediately affix and lock a tag to a salmon caught for the disabled angler in the manner described in subsection 6(3).
- (3) Where a designated angler retains and tags a salmon, the disabled angler shall immediately take possession of and retain the salmon.

2. The school boards for school districts 2, 3, 4, 5, 6, 7, 8, 9, and 10 as defined in the *Boundaries of School Districts Order* are dissolved.

- **3.** The school boards for school districts 2, 3 and 4, as defined by the *Boundaries of School Districts Order*, 2004, are the successors in law to, and shall assume the assets, debits and liabilities of, the school boards dissolved by section 2 as follows:
 - (a) district 2 for districts 2, 3 and 4;
 - (b) district 3 for districts 5 and 6; and
 - (c) district 4 for districts 7, 8, 9 and 10.

1. This Order may be cited as the Boundaries of School Districts Order, 2004.

Districts

2. The province is divided into the following school districts:

District # 1 - LABRADOR

Labrador district shall include the area bounded by a line commencing at Norman Bay, exclusive, and extending in a southerly direction to Charlottetown, Labrador, exclusive, and then to Port Hope Simpson, exclusive, and then to L'Anse au Clair, exclusive, and then in a westerly and northerly direction along the Quebec border, and then in a southerly direction around the coast to the point of commencement.

District # 2 - WESTERN NEWFOUNDLAND

The Western Newfoundland District shall include the area bounded by a line commencing at Norman Bay, inclusive, and extending in a southerly direction around the coast to Chateau Bay, and then across the Strait of Belle Isle to Big Brook, and then in an easterly direction around the coast of the Northern Peninsula to Harbour Deep, and then in a southerly direction around the coast to The Beeches, inclusive, and then in a southerly direction to the southwest tip of Red Indian Lake, and then in a southerly direction to Francois, inclusive, and then in a westerly and northerly direction around the coast to Pond Cove, and then across the Strait of Belle Isle to l'Anse au Clair, inclusive, and then in a northeasterly direction along the boundary of District 1 to the point of commencement.

District #3 - CENTRAL NEWFOUNDLAND

The Central Newfoundland District shall include the area bounded by a line commencing at The Beaches, exclusive, and extending in a northerly and easterly direction around the coast to Charlottetown, Bonavista Bay, inclusive and then in a southwesterly direction to Port Blandford, exclusive, and then to Rencontre East, inclusive, and then in a westerly direction around the coast to Francois, exclusive, and then in a northerly direction along the boarder of District 2 to the point of commencement.

District # 4 - EASTERN NEWFOUNDLAND

The Eastern Newfoundland District shall include the area bounded by a line commencing at Charlottetown, Bonavista Bay, exclusive, and extending in a southwesterly direction along the boundary of District 3 to Recontre East, exclusive, and extending in an easterly direction to Grand LePierre, and then in a southerly and easterly direction around the coast to Cape Race, and then in an northeasterly direction

tion around the coast to Cape St. Frances, and then in a northwesterly direction around the coast, around Bell Island, to the point of commencement.

CONSEIL SCHOLAIRE FRANCOPHONE

The school district covers the entire province.

Repeal

3. The *Boundaries of School Districts Order*, Newfoundland and Labrador Regulation 79/96, is repealed.

4. This Order comes into force on September 1, 2004.

 - (i) headquarters Happy Valley-Goose Bay, and
 - (ii) regional education centre Labrador City/Wabush;
- (b) District 2
 - (i) headquarters Corner Brook, and
 - (ii) regional education centres Stephenville and Lower Cove;
- (c) District 3
 - (i) headquarters Gander, and
 - (ii) regional education centre Grand Falls-Windsor; and
- (d) District 4
 - (i) headquarters St. John's, and
 - (ii) regional education centres Burin, Clarenville and Spaniard's Bay.

Commencement

3. These regulations come into force on September 1, 2004.
