The proposed change is from Comprehensive Residential Development Area and Open Space to Residential. In general terms, the purpose of Municipal Plan Amendment 2004-1 is to change the land use designation of an area of land currently identified as Comprehensive Residential Development Area in the Humbermouth/Humber Heights area, as well as a small portion of adjoining Open Space land, to Residential. The amendment is necessary in order to redesignate the existing development area now that the road improvements have been completed and to permit development of those areas of vacant land that are suitable for development.

The proposed change is from Comprehensive Residential Development Area and Open Space to Residential Medium Density. In general terms, the purpose of Development Regulations Amendment 2004-1 is to change the land use zoning of the above described area of land from Comprehensive Residential Development Area and Open Space to Residential Medium Density. The amendment is necessary in order to rezone the existing developed area now that the necessary road improvements have been completed and to permit development of those areas of vacant land that are suitable for development.

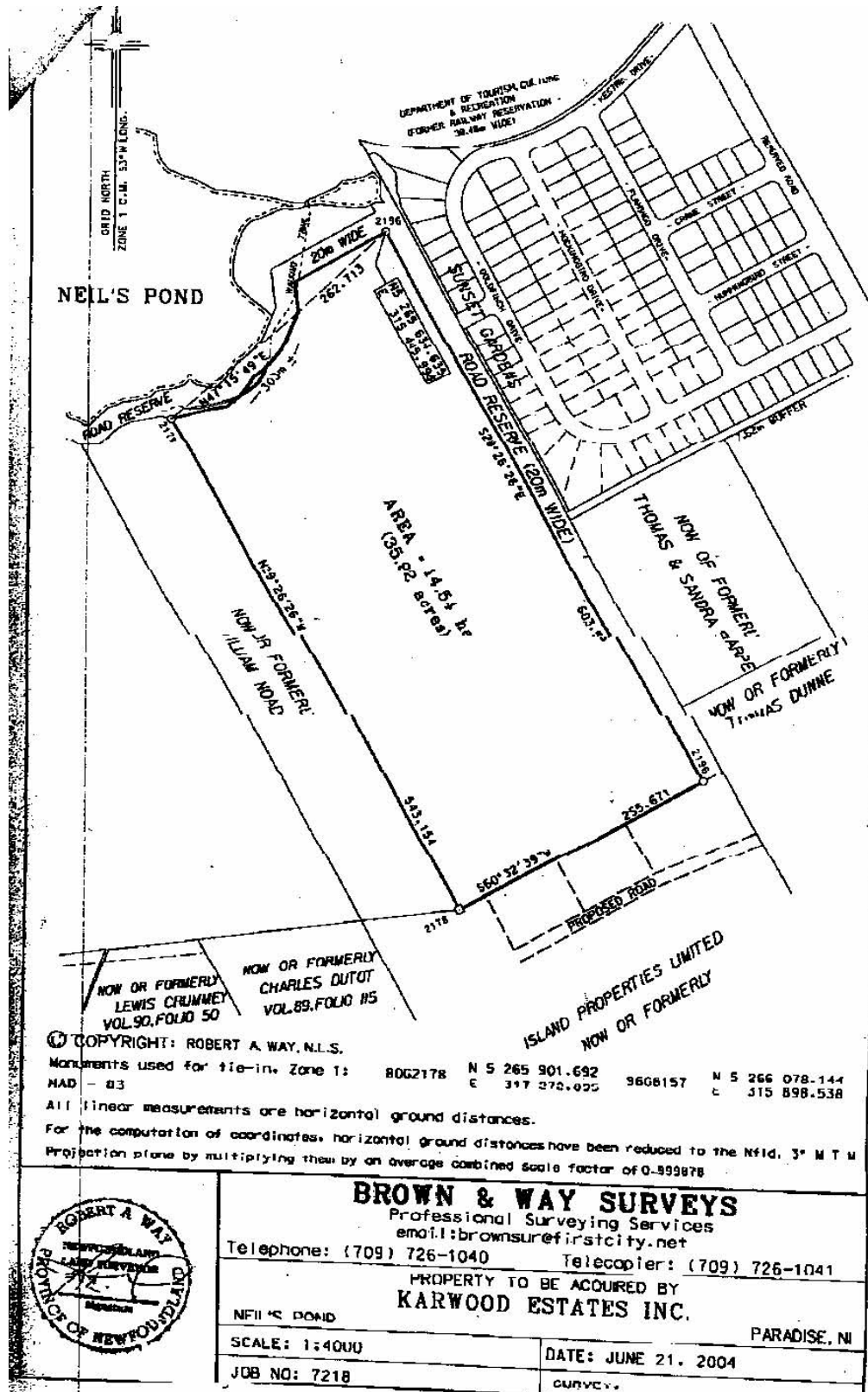
