NOTICE PUBLIC HEARING TOWNS OF ST. LAWRENCE/ LAWN FEASIBILITY REPORT

Submissions will be deposited in sealed

envelopes clearly marked "Public Hearing, St. Lawrence/Lawn Feasibility Report". If no representation with respect to the St. Lawrence/Lawn Feasibility Report are received within the time indicated, the hearing may be cancelled.





- (g) child, youth and family services; and
- (h) services to adult individuals.

Western Regional Integrated Health Authority constituted

- (2) The Western Regional Integrated Health Authority is assigned the supervision, direction and control of the delivery of health and community services in the areas of
 - (a) health and community prevention and promotion;
 - (b) road ambulance services;
 - (c) health and community protection;
 - (d) continuing care;
 - (e) mental health;
 - (f) addiction services;
 - (g) child, youth and family services; and
 - (h) services to adult individuals.

Labrador-Grenfell Regional Integrated Health Authority constituted

- **5.** (1) An authority, known as the Labrador-Grenfell Regional Integrated Health Authority, is constituted to manage and control the operation of the facilities included in Schedule D and all other facilities, services and programs operated or provided by them or associated with them.
- (2) The Labrador-Grenfell Regional Integrated Health Authority is assigned the supervision, direction and control of the delivery of health and community services in the areas of

Deduction from payroll

27. Under section 102 of the Act, in computing and adjusting the amount of the payroll of an employer, an amount in excess of the maximum compensable earnings, calculated under section 21, paid to a worker shall be deducted from the amount of the payroll and the assessment shall be based on the payroll as reduced.
