NOTICE OF REGISTRATION CITY OF CORNER BROOK MUNICIPAL PLAN AMENDMENT 2005-1 AND DEVELOPMENT REGULATIONS AMENDMENT 2005-1

Take notice that the City of Corner Brook Municipal Plan Amendment 2005-1 and Development Regulations Amendment 2005-1, adopted on the 20th day of July, 2005, and approved on the 17th day August, 2005, have been registered by the Minister of Municipal Affairs.

The purposed change is from Open Space to Community Service. The purpose of Municipal Plan Amendment 2005-1 is to change the land use designation of an area of land located at the end of University Avenue adjacent (north east) to the Sir Wilfred Grenfell College grounds/parking lot from Open Space to Community Service in order to permit development of a regional long term care facility.

The proposed change is from Open Space to Community Service. The purpose of Development Regulations Amendment 2005-1 is to change the land use zoning of an area of land located at the end of University Avenue adjacent (north east) to the Sir Wilfred Grenfell College grounds/parking lot from Open Space to Community

Service in order to permit development of a regional long term care facility.

The Corner Brook Municipal Plan Amendment 2005-1 and Development Regulations Amendment 2005-1 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. 

Then running in a southeasterly direction for a distance of 220 metres, more or less, to a point having scaled UTM coordinates of easting 505 881 metres and northing 5 510 117 metres;

Then running in a southwesterly direction for a distance of 201 metres, more or less, to the point of commencement.

 - (a) striking out the word "director" wherever it occurs and substituting the word "superintendent"; and
 - (b) striking out the word "registrar" and substituting the word "superintendent".
- (5) Section 198 of the regulations is amended by striking out the introductory portion of subsection (8) and substituting the following:
- (8) The superintendent shall object to a proposed offering memorandum prospectus if it appears to him or her that any of the following circumstances exist:
- (6) Paragraphs 198(8)(e) and (f) of the regulations are amended by striking out the word "director" wherever it occurs and substituting the word "superintendent".
