Take notice that the Town of Steady Brook Development Regulations Amendment No. 4, 2004 adopted on the 1st day of March, 2006, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of the Development Regulations Amendment No. 4, 2004, is to re-zone properties located on the north and south side of Marble Drive from Open Space to Residential Medium Density and Residential Medium Density Floodway Fringe, re-zone property on the west side of Musgrave Drive from Mixed Development to Comprehensive Development Area, re-zone property on the east and west side of Wilton Street from Transportation Utility to Open Space, and to outline conditions for Flood Risk Areas and Flood Fringe Areas.

The Town of Steady Brook Development Regulations Amendment No. 4, 2004, comes into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.
