In general terms, the purpose of Municipal Plan Amendment No. 4, 2004 is to make changes to Flood Risk Area designations and restrictions, and update the Town of Steady Brook's Land Use Map.

In general terms, the purpose of the Development Regulations Amendment No. 4, 2004 is to re-zone properties located on the north and south side of marble drive from Open Space to Residential Medium Density and Residential Medium Density Floodway Fringe, rezone property on the west side of Musgrave Drive from Mixed Development to Comprehensive Development Area, rezone property on the east and west side of Wilton Street from Transportation Utility to Open Space, and to outline conditions for Flood Risk Areas and Flood Fringe Areas.

NLR 40/98 as amended 1. Second 7 of the *Child Support Guidelines Regulations* is amended by adding immediately after subsection (1) the following:

- (1.1) For the purposes of paragraphs (1)(d) and (f), the term "extraordinary expenses" means
  - (a) expenses that exceed those that the spouse requesting an amount for the extraordinary expenses can reasonably cover, taking into account that spouse's income and the amount that the spouse would receive under the applicable table or, where the court has determined that the table amount is inappropriate, the amount that the court has otherwise determined is appropriate; or
  - (b) where paragraph (a) is not applicable, expenses that the court considers are extraordinary taking into account
    - (i) the amount of the expense in relation to the income of the spouse requesting the amount, including the amount that the spouse would receive under the applicable table or, where the court has determined the table amount is inappropriate, the amount that the court has otherwise determined is appropriate,
    - (ii) the nature and number of the educational programs and extracurricular activities,
    - (iii) special needs and talents of the child or children,
    - (iv) the overall cost of the programs and activities, and
    - (v) other similar factor that the court considers relevant.

### 2. Section 18 of the regulations is repealed and the following substituted:

Non-resident

- **18.** (1) Where a spouse is a non-resident of Canada, the spouse's annual income is determined as though the spouse were a resident of Canada.
- (2) Notwithstanding subsection (1), where a spouse is a nonresident of Canada and resides in a country that has effective rates of income tax that are significantly higher than those applicable in the province in which the other spouse ordinarily resides, the spouse's annual income is the amount that the court determines to be appropriate taking those rates into consideration.

## 3. Step 1 of the section 2 of Schedule A of the regulations is repealed and the following substituted:

#### STEP 1

Establish the annual income of each person in each household by applying the formula

where

- A = is the person's income determined under sections 15 to 20 of these guidelines,
- B = is the federal and provincial taxes payable on the person's taxable income, and
- C = is the person's source deductions for premiums paid under the *Employment Insurance Act* (Canada) and contributions made to the *Canada Pension Plan* (Canada) and the *Quebec Pension Plan*.

Where the information on which to base the income determination is not provided, the court may impute income in the amount it considers appropriate.

Commencement

4. These regulations come into force on May 1, 2006.

Orma South Adjunct Zone	December 17, 2005 - December 24, 2005

# 2. Section 5 of the Order is repealed and the following substituted:

Closed season

- **5.** There shall be a closed season in the following zones:
  - (a) Big River Zone.
  - (b) Double Mer Barrens Zone;
  - (c) Lac Virot Zone;
  - (d) Sawbill Lake Zone;
  - (e) Bay of Islands Zone;
  - (f) Grand Lake Zone;
  - (g) McPhayden River Zone;

- (h) Milner Lake Zone; and
- (i) Muilligan River Zone.

# 3. The Schedule to the Order is amended by adding immediately after the description of "Mulligan River" the following:

#### (t) Orma South Adjunct Zone

All that area commencing at the Metchin River outlet on an unnamed lake located at 53° 36′ 4.9" north latitude and 62° 55′ 41" west longitude;

Then following a straight line in a southerly direction to the west abutment of East Wilson River Bridge;

Then following the north bank of the East Wilson River in a westerly direction to its intersection with Main Wilson River;

Then following the north bank of Main Wilson River to its junction with West Metchin River; and

Then following the west bank of the East Metchin River north to the point of commencement.
