**MUNICIPAL PLAN AMENDMENT NO. 8 AND
DEVELOPMENT REGULATIONS
AMENDMENT NO. 20, 2005**

In general terms, the purpose of Municipal Plan Amendment No. 8, 2005 is to amend the Rural Residential policy to allow, at Council's discretion, the extension of an existing subdivision with development standards that are consistent with the surrounding built-up area. In such circumstances, the proposed new development must result in continuity in terms of lot size, street design, and must result in the elimination of dead-end streets by connecting them to existing roads.

The Amendment will also re-designate a parcel of land located east of Chesley Van Heights from Rural to Rural Residential and Agriculture to Rural Residential.

Development Regulations Amendment No. 20, 2005, will re-zone the same parcel of land located east of Chesley Van Heights, from Rural (RUR) to Residential Infill (RI). The

amendment is required to allow for the extension of the Chesley Van Heights Subdivision with a minimum lot size of 1860 m².

**MUNICIPAL PLAN AMENDMENT NO. 9 AND
DEVELOPMENT REGULATIONS
AMENDMENT NO. 21, 2005**

The purpose of Municipal Plan Amendment No. 9, 2005 is to re-designate a parcel of land located in the vicinity of Emberleys Road and Round Pond Road from Development Scheme Area 6 (Residential Estate) to Rural Residential. The Amendment will also re-designate the southern area of the Scheme Area from Development Scheme Area 6 (Residential Estate) to Development Scheme Area 6 (Rural Residential).

Development Regulations Amendment No. 21, 2005, will re-zone a parcel of land in the vicinity of Emberleys Road and Round Pond Road from Rural Residential (RR) to Residential Infill (RI). The purpose of the Amendment will allow for existing vacant land to be developed with a minimum area of 1860m².

**MUNICIPAL PLAN AMENDMENT NO. 10 AND
DEVELOPMENT REGULATIONS AMENDMENT NO.
23, 2005**

The purpose of Municipal Plan Amendment No. 10, 2005 is to re-designate a parcel of land located west, off Portugal Cove Road, from Development Scheme Area 5 (Rural Residential) to Residential Serviced.

Development Regulations Amendment No. 23, 2005, will re-zone a portion of the same parcel of land from "Development Scheme Area 5: Portugal Cove – Opposite Murray's Pond" to "Residential Medium Density". The purpose of the Amendment is to allow for the development of vacant land with a minimum lot size of 1860 m².

1. This Order may be cited as the *Town of Little Bay Order*.

2. The boundaries of the Town of Little Bay are as set out in the Schedule.

Repeal

3. Newfoundland Regulation 722/78 is repealed.

Beginning at a point in the northwest shoreline of Little Bay, that point having reference 625 metres, more or less, northeast of the community church and then running north 23° west 202 metres, more or less;

Then running south 66° west 1400 metres, more or less;

Then running south 25° east 525 metres, more or less;

Then running south 5° 30' east 175 metres, more or less;

Then running south 25° 30' west 250 metres, more or less;

Then running south 55° 30' west 880 metres, more or less;

Then running north 55° east 550 metres, more or less;

Then running north 4° west 400 metres, more or less;

Then running north 50° east 457 metres, more or less;

Then running north 29° 10' west 188 metres, more or less, to a point in the northeast shoreline of Little Bay;

Then running in a generally southwesterly and northeasterly direction along the shoreline of Little Bay to the point of beginning.

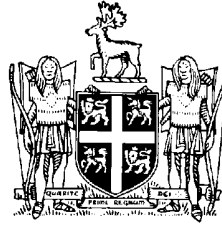

(2) Paragraph 2(e) of the regulations is repealed and the following substituted:

(e) "emergency first aid certificate" means a certificate that meets the criteria established by the commission under section 3.1 with respect to emergency first aid certificates referred to at paragraph 3.1(1)(b);

(3) Paragraph 2(j) of the regulations is repealed and the following substituted:

(j) "standard first aid certificate" means a certificate that meets the criteria established by the commission under section 3.1 with respect to standard first aid certificates referred to at paragraph 3.1(1)(c).

2. The regulations are amended by adding immediately after section 3 the following:

First aid certificates

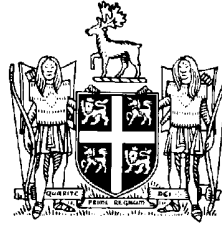
3.1 (1) The commission shall establish the education, practical training and other criteria required for a person to be issued a certificate of

- (a) advanced first aid;
- (b) emergency first aid; and
- (c) standard first aid.

(2) Where a course or program is offered by a person or organization that provides the education, practical training and other criteria that the commission considers to be equivalent to that required under subsection (1), the commission may designate that course or program as offered by that person or organization as acceptable for the purpose of that subsection.

(3) In this section "commission" means the Workplace Health, Safety and Compensation Commission continued under section 3 of the *Workplace Health, Safety and Compensation Act*.
